Predictive Services Discussion:

Hot temperatures will continue in California today, with much of the lower elevations below 2,000 feet exceeding 100°F away from the coast. Very dry conditions will stretch from interior California through the southern Intermountain West with minimum relative humidity of 3-15% and poor overnight recovery. Above normal temperatures will spread into the Pacific Northwest with low relative humidity, as well, although winds will be light. Areas of breezy westerly sustained winds of 12-20 mph with gusts up to 30 mph will persist in much of Arizona into the eastern Great Basin, Wyoming, and West Slope creating locally elevated conditions. Isolated mixed wet and dry thunderstorms will continue in the central and southern Rockies east of the Divide, with wetter storms for the adjacent High Plains. For the eastern US, isolated to scattered showers and thunderstorms will develop across the Southeast and much of the Eastern Seaboard, while a cold front brings widespread thunderstorms to the Midwest. A warming trend will commence across much of Alaska with warm temperatures in the Interior, with the lowest relative humidity in the northern Interior due to downsloping north winds off the Brooks Range.
