Hope, Northeast Region, Washington DNR. CIMT (NW Team 8). Started on private land 15 miles north of Kettle Falls, WA. Timber and brush. Moderate fire behavior with wind-driven runs, Isolated torching and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Western Pines, Northeast Region, Washington DNR. Started on private land 10 miles north of Davenport, WA. Closed timber litter and timber. Moderate fire behavior with smoldering, creeping and backing. Structures threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

Elk, Klamath Unit, Oregon DOF. CIMT (ODF Team 1). Seven miles southwest of Beatty, OR. Timber and closed timber litter. Active fire behavior with spotting, single tree torching and smoldering. Numerous structures and energy infrastructure threatened. Evacuations, area and road closures in effect.

Grizzly Complex, Medford Unit, Oregon DOF. CIMT (ODF Team 3). Twenty miles west of Medford, OR. Timber and brush. Moderate fire behavior with flanking, backing and creeping. Several communities threatened. Evacuations and road closures in effect.

Pomas, Okanogan-Wenatchee NF, USFS. CIMT (NW Team 12). Thirty-six miles northwest of Entiat, WA. Grass, timber and light slash. Active fire behavior with backing, creeping and isolated torching.

Willow, Prineville District, BLM. Twenty miles south of Paulina, OR. Grass and brush. Minimal fire behavior. Structures and Sage-grouse habitat threatened.

Bear Gulch, Olympic NF, USFS. Ten miles northwest of Hoodspport, WA. Timber. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect.

Long Point, Monument Unit, Oregon DOF. Eight miles east of Spray, OR. Grass and brush. Minimal fire behavior with smoldering and creeping. Structures threatened. Reduction in acreage due to more accurate mapping.

* **Highland**, Prineville District, BLM. Started on private land one mile south of Prineville, OR. Brush and grass. Active fire behavior with wind-driven runs, torching and spotting. Numerous structures threatened. Evacuations, area and road closures in effect.

Sunrise, Prineville District, BLM. Eight miles south of Paulina, OR. Grass and brush. Minimal fire behavior. Structures and Sage-grouse habitat threatened. Area closures in effect. Last report unless significant activity occurs.

Nenana Ridge Complex (2 fires), Fairbanks Area, Alaska DOF. CIMT (AK Team 2). Started on Alaska DNR land 20 miles southwest of Fairbanks, AK. Timber, hardwood litter and brush. Active fire behavior with creeping and smoldering. Structures threatened. Evacuations, area, road and trail closures in effect.

Himalaya Road, Fairbanks Area, Alaska DOF. Transfer of command from CIMT (SW Team 3) to CIMT (RM Team 2) will occur tomorrow. CIMT is also managing the Aggie Creek incident. Started on Alaska DNR land 12 miles northwest of Fox, AK. Chaparral and timber. Minimal fire behavior with smoldering. Numerous residences and energy infrastructure threatened. Evacuations and road closures in effect.

Aggie Creek, Fairbanks Area, Alaska DOF. Started on Alaska DNR land 23 miles northwest of Fairbanks, AK. Chaparral and timber. Moderate fire behavior with creeping, isolated torching and smoldering. Residences and energy infrastructure threatened. Road closures in effect. Reduction in acreage due to more accurate mapping.

Seven Mile Lookout, Tok Area, Alaska DOF. Started on Alaska DNR land seven miles southwest of Tok, AK. Timber. Minimal fire behavior with smoldering and backing. Residences threatened.

Tsukon, Upper Yukon Zone, BLM. Started on Alaska Native Corporation land 17 miles northwest of Venetie, AK. Closed timber litter and brush. Minimal fire behavior with smoldering and creeping.

Goldrun Complex (4 fires), Galena Zone, BLM. Started on NPS land 13 miles northwest of Ambler, AK. Hardwood litter, timber and brush. Extreme fire behavior with long range spotting, crowning and wind-driven runs. Residences threatened. Last narrative report unless significant activity occurs.

Roundabout Complex (3 fires), Galena Zone, BLM. Started on FWS land eight miles southwest of Huslia, AK. Timber and brush. Active fire behavior with group torching, wind-driven runs and flanking. Structures threatened. Last narrative report unless significant activity occurs.

Ptarmigan Complex (5 fires), Upper Yukon Zone, BLM. Previously reported incident. Two miles south of Central, AK. Brush, timber and hardwood litter. Moderate fire behavior with creeping and smoldering. Numerous residences and energy infrastructure threatened. Last narrative report unless significant activity occurs.

Chabanika, Tanana Zone, BLM. Previously reported incident. Twenty-eight miles northwest of Allakaket, AK. Timber. Moderate fire behavior with flanking and creeping. Last narrative report unless significant activity occurs.

Hogatza, Tanana Zone, BLM. Previously reported incident. Started on DNR land 39 miles northwest of Allakaket, AK. Timber. Active fire behavior with running and torching. Last narrative report unless significant activity occurs.

Moran, Tanana Zone, BLM. Previously reported incident. Started on Alaska DNR land 27 miles northwest of Tanana, AK. Timber and brush. Moderate fire behavior with running. Last narrative report unless significant activity occurs.

Predictive Services Discussion:

Above normal temperatures will continue across the West amid minimum relative humidity of 5-20%, with the greatest anomalies of 10-15°F above normal in California and the Northwest. Breezy westerly winds 12-25 mph with gusts 25-40 mph will create elevated to locally critical conditions in the Cascade Gaps and Columbia Basin. Isolated to scattered mixed wet and dry thunderstorms will develop near and east of the Divide in Colorado and New Mexico, then westward along the Mogollon Rim. Very isolated dry thunderstorms are possible in far northeast California and south-central Oregon late this afternoon. Scattered showers and thunderstorms, a few severe, will develop along and ahead of a cold front from the southern Plains northeast through the Ohio Valley into the Northeast and Mid-Atlantic. A drier day is expected in the Southeast with fewer thunderstorms, except across Florida where thunderstorms will remain scattered. Warm and dry conditions will continue in Interior Alaska, with minimum relative humidity of 25-35% amid widespread temperatures in the 70s. Isolated thunderstorms are also possible in portions of the western Interior into the Alaska Range.
