Grizzly Complex, Medford Unit, Oregon DOF. CIMT (ODF Team 3). Twenty miles west of Medford, OR. Timber and brush. Minimal fire behavior with smoldering and creeping. Several communities threatened. Evacuations and road closures in effect.

Elk, Klamath Unit, Oregon DOF. CIMT (ODF Team 1). Seven miles southwest of Beatty, OR. Timber and closed timber litter. Active fire behavior with spotting, single tree torching and smoldering. Numerous structures and energy infrastructure threatened. Evacuations, area and road closures in effect.

Hope, Northeast Region, Washington DNR. CIMT (NW Team 8). Started on private land 15 miles north of Kettle Falls, WA. Timber and brush. Active fire behavior with wind-driven runs, torching and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Pomas, Okanogan-Wenatchee NF, USFS. CIMT (NW Team 12). Thirty-six miles northwest of Entiat, WA. Grass, timber and light slash. Active fire behavior with backing, creeping and isolated torching. Area, road and trail closures in effect.

Western Pines, Northeast Region, Washington DNR. Started on private land 10 miles north of Davenport, WA. Closed timber litter and timber. Moderate fire behavior with smoldering, creeping and backing. Structures threatened. Evacuations, area, road and trail closures in effect.

Long Point, Monument Unit, Oregon DOF. Eight miles east of Spray, OR. Grass and brush. Minimal fire behavior with smoldering and creeping.

Highland, Prineville District, BLM. Started on private land one mile south of Prineville, OR. Brush and grass. Moderate fire behavior with single tree torching and creeping. Numerous structures threatened. Evacuations, area and road closures in effect. Reduction in size due to more accurate mapping.

Bear Gulch, Olympic NF, USFS. Ten miles northwest of Hoodspport, WA. Timber. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect.

* **Cram**, Prineville District, BLM. Fifteen miles north of Madras, OR. Grass, brush and timber. Extreme fire behavior with crowning, running and spotting. Residences threatened. Evacuations and road closures in effect.

* **Coyote**, Vale District, BLM. Nineteen miles south of Jordan Vally, OR. Brush and grass. Active fire behavior with running and single tree torching. Structures and sage-grouse habitat threatened.

Willow, Prineville District, BLM. Twenty miles south of Paulina, OR. Grass and brush. No new information.

Nenana Ridge Complex (2 fires), Fairbanks Area, Alaska DOF. CIMT (AK Team 2). Started on Alaska DNR land 20 miles southwest of Fairbanks, AK. Timber, hardwood litter and brush. Active fire behavior with creeping torching and spotting. Structures threatened. Evacuations, area, road and trail closures in effect.

Himalaya Road, Fairbanks Area, Alaska DOF. Transfer of command from CIMT (SW Team 3) to CIMT (RM Team 2) will occur today. CIMT is also managing the Aggie Creek incident. Started on Alaska DNR land 12 miles northwest of Fox, AK. Chaparral and timber. Minimal fire behavior with smoldering. Numerous residences and energy infrastructure threatened. Evacuations and road closures in effect.

Aggie Creek, Fairbanks Area, Alaska DOF. Started on Alaska DNR land 23 miles northwest of Fairbanks, AK. Chaparral and timber. Moderate fire behavior with creeping, isolated torching and smoldering. Residences and energy infrastructure threatened. Road closures in effect.

Tsukon, Upper Yukon Zone, BLM. Started on Alaska Native Corporation land 17 miles northwest of Venetie, AK. Closed timber litter and brush. Minimal fire behavior with smoldering and creeping.

Seven Mile Lookout, Tok Area, Alaska DOF. Started on Alaska DNR land seven miles southwest of Tok, AK. Timber. Minimal fire behavior with smoldering and backing. Residences threatened.

Goldrun Complex (4 fires), Galena Zone, BLM. Started on NPS land 13 miles northwest of Ambler, AK. Hardwood litter, timber and brush. Extreme fire behavior with crowning, group torching and short-range spotting. Residences threatened. Last narrative report unless significant activity occurs.

Roundabout Complex (3 fires), Galena Zone, BLM. Started on FWS land eight miles southwest of Huslia, AK. Timber and brush. Extreme fire behavior with short crown runs, running and flanking. Structures threatened. Last narrative report unless significant activity occurs.

* **Onion**, Galena Zone, BLM. Started on Alaska Native Corporation land eight miles west of Ambler, AK. Brush and timber. Extreme fire behavior with crowning, group torching and short-range spotting. Last narrative report unless significant activity occurs.

* **Portage**, Tanana Zone, BLM. Started on Alaska DNR land 43 miles northwest of Alatna, AK. Timber. Minimal fire behavior. Last narrative report unless significant activity occurs.

* **McQuisten**, Tanana Zone, BLM. Thirty-two miles northeast of Tanana, AK. Brush and timber. Moderate fire behavior with flanking and creeping. Last narrative report unless significant activity occurs.

* **Ulaneak**, Galena Zone, BLM. Started on Alaska DNR land 33 miles northeast of Kobuk, AK. Timber. Minimal fire behavior. Last narrative report unless significant activity occurs.

* **Reed**, Galena Zone, BLM. Started on Alaska DNR land 57 miles northeast of Kobuk, AK. Timber. Minimal fire behavior. Last narrative report unless significant activity occurs.

* **Muskox**, Tanana Zone, BLM. Started on Alaska DNR land 48 miles northwest of Alatna, AK. Timber. Minimal fire behavior. Last narrative report unless significant activity occurs.

* **Horseshoe**, Tanana Zone, BLM. Started on FWS land 35 miles east of Ruby, AK. Timber. Minimal fire behavior with smoldering and creeping. Last narrative report unless significant activity occurs.

* **Polly**, Upper Yukon Zone, BLM. Twenty-one miles northeast of Chicken, AK. Timber. Moderate fire behavior with running and creeping. Last narrative report unless significant activity occurs.

* **Thluichohnjik**, Upper Yukon Zone, BLM. Started on FWS land 47 miles southeast of Arctic Village, AK. Timber. Minimal fire behavior. Last narrative report unless significant activity occurs.

* **Continental**, Tanana Zone, BLM. Started on Alaska DNR land 40 miles northwest of Alatna, AK. Timber. Minimal fire behavior. Last narrative report unless significant activity occurs.

Predictive Services Discussion:

A strong cold front will move through Washington and the northern Rockies today, with breezy westerly winds 12-25 mph with gusts 25-40 mph amid minimum relative humidities of 5-20% will create elevated to critical conditions for the Inland Northwest, Sierra Front, and Snake River Plain. Locally strong northerly winds gusting to 60 mph will develop behind the front in the Okanogan Valley of northern Washington. Scattered showers and thunderstorms will develop near and behind the front across Montana east of the Divide overnight and into the northern Plains. Above normal temperatures will persist across much of California through the southern Intermountain West, as well, with continued low humidity. Isolated to scattered mixed wet and dry thunderstorms will develop near and east of the Divide in Colorado and New Mexico into southeast Arizona and also westward along the Mogollon Rim. Isolated dry thunderstorms will develop across far northern California into northern Nevada and northwest Utah, as well. Isolated showers and thunderstorms will develop from the southern Plains to the Ohio and Tennessee Valleys, with scattered showers and thunderstorms along the Eastern Seaboard. Warm conditions will continue in central and eastern Interior Alaska, with isolated thunderstorms, while the western Interior turns cooler with a few light showers.
