**Monroe Canyon**, Fishlake NF, USFS. CIMT (GB Team 3). Three miles east of Monroe, UT. Timber. Active fire behavior with crowning, group torching and spotting. Numerous structures and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Deer Creek**, Southeast Area, Utah DOF. CIMT (GB Team 4). Twenty-five miles southeast of Moab, UT. Timber, chaparral and brush. Active fire behavior with flanking, creeping and torching. Several communities threatened. Evacuations, area, road and trail closures in effect.

**White Sage**, Arizona Strip District, BLM. CIMT (GB Team 6). Fifteen miles southeast of Fredonia, AZ. Timber and brush. Extreme fire behavior with running, wind-driven runs and short crown runs. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Forsyth**, Dixie NF, USFS. CIMT (GB Team 2). Thirty miles north of St. George, UT. Timber and brush. Moderate fire behavior with torching, creeping and smoldering. Numerous structures and energy infrastructure threatened. Area, road and trail closures in effect.

**Hot Canyon**, Elko District, BLM. Ten miles northwest of Montello, NV. Timber, brush and grass. Minimal fire behavior with creeping and smoldering. Structures and sage-grouse habitat threatened.

\* **Tindall**, Boise District, BLM. Fourteen miles southwest of Mountain Home, ID. Grass and brush. Active fire behavior with running and wind-driven runs. Structures threatened.

\* **Cornucopia**, Elko District, BLM. Sixteen miles north of Tuscarora, NV. Brush and grass. Extreme fire behavior with running, flanking and wind-driven runs. Numerous structures and energy infrastructure threatened.

**Hope**, Northeast Region, Washington DNR. CIMT (NW Team 8). Started on private land 15 miles north of Kettle Falls, WA. Timber and brush. Moderate fire behavior with wind-driven runs, torching and short-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

**Elk**, Klamath Unit, Oregon DOF. CIMT (ODF Team 1). CIMT is also managing the Hagelstein incident. Seven miles southwest of Beatty, OR. Timber and closed timber litter. Active fire behavior with spotting, single tree torching and smoldering. Numerous structures and energy infrastructure threatened. Evacuations, area and road closures in effect.

\* **Hagelstein**, Klamath Unit, Oregon DOF. Four miles southeast of Modoc Point, OR. Timber and light slash. Active fire behavior with flanking, single tree torching and spotting. Area and road closures in effect. Energy infrastructure threatened.

**Grizzly Complex**, Medford Unit, Oregon DOF. CIMT (ODF Team 3). Twenty miles west of Medford, OR. Timber and brush. Minimal fire behavior with smoldering. Several communities threatened. Evacuations and road closures in effect. Reduction in acreage due to more accurate mapping.

**Pomas**, Okanogan-Wenatchee NF, USFS. CIMT (NW Team 12). Thirty-six miles northwest of Entiat, WA. Grass, timber and light slash. Active fire behavior with backing, creeping and isolated torching. Area, road and trail closures in effect.

**Cram**, Prineville District, BLM. CIMT (NW Team 10). Fifteen miles north of Madras, OR. Grass, brush and timber. Extreme fire behavior with crowning, running and spotting. Residences threatened. Evacuations and road closures in effect.

**Greenacres**, Northeast Region, Washington DNR. Started on county land five miles north of Omak, WA. Grass and brush. Minimal fire behavior with smoldering. Numerous structures threatened. Evacuations, area and road closures in effect.

**Western Pines**, Northeast Region, Washington DNR. Started on private land 10 miles north of Davenport, WA. Closed timber litter and timber. Moderate fire behavior with smoldering, creeping and backing. Structures threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

**Highland**, Prineville District, BLM. Started on private land one mile south of Prineville, OR. Brush and grass. Minimal fire behavior with creeping and smoldering. Numerous structures threatened. Evacuations, area and road closures in effect.

**Bear Gulch**, Olympic NF, USFS. Ten miles northwest of Hoodspport, WA. Timber. Minimal fire behavior with creeping. Area, road and trail closures in effect.

\* **Daybreak**, Vale District, BLM. Twelve miles north of Huntington, OR. Grass and brush. Active fire behavior with wind-driven runs and running. Structures threatened. Evacuations and road closures in effect.

\* **Boundary Road**, Yakima Agency, BIA. Thirty miles southeast of Toppenish, WA. Grass and brush. Extreme fire behavior with wind-driven runs, running and flanking.

**Himalaya Road**, Fairbanks Area, Alaska DOF. CIMT (RM Team 2). CIMT is also managing the Aggie Creek incident. Started on Alaska DNR land 12 miles northwest of Fox, AK. Chaparral and timber. Minimal fire behavior with smoldering. Numerous residences and energy infrastructure threatened. Evacuations and road closures in effect. Precipitation occurred over the fire area yesterday.

**Aggie Creek**, Fairbanks Area, Alaska DOF. Started on Alaska DNR land 23 miles northwest of Fairbanks, AK. Chaparral and timber. Moderate fire behavior with creeping, isolated torching and smoldering. Residences and energy infrastructure threatened. Road closures in effect. Precipitation occurred over the fire area yesterday.

**Seven Mile Lookout**, Tok Area, Alaska DOF. Started on Alaska DNR land seven miles southwest of Tok, AK. Timber. Minimal fire behavior with smoldering and isolated torching. Residences threatened.

## **Predictive Services Discussion:**

Gusty west to southwest winds will result in elevated to locally critical fire weather conditions across the southern Great Basin and northwest Arizona, with enhanced west winds in the Snake River Plain, as well. Minimum RH of 7-15% will be the rule again across much of the Great Basin into the West Slope and most of the Arizona Strip. Isolated mixed wet and dry thunderstorms will develop from central Nevada into the Four Corners and southwest Wyoming, while scattered wet thunderstorms develop from the Mogollon Rim into southern Arizona and much of New Mexico. Dry conditions are expected across the Northwest, with hotter temperatures locally approaching the century mark and RH as low as 10-25% west of the Cascades. These warmer conditions will be the result of thermal troughing that may lead to an increase in activity over the Olympic Peninsula. Onshore flow will deepen over California, bringing near average temperatures and an uptick in humidity.

Farther east, a cold front will trigger scattered to widespread showers and thunderstorms from the Front Range to the Upper Midwest, while the Southern Plains will begin to dry out. Temperatures will be as much as 20-30 degrees below average over the northern Rockies and Upper Midwest. Look for thunderstorms with flash flood potential over portions of the Appalachians, in addition to the eastern Gulf Coast as a tropical wave tracks by just offshore.

Waves of showers will continue to overspread western and central Alaska, maintaining below average temperatures and improvement in the fire environment. Eastern parts of the state will be dry but seasonably mild.
