Monroe Canyon, Fishlake NF, USFS. CIMT (GB Team 3). Three miles east of Monroe, UT. Timber. Moderate fire behavior with single tree torching, group torching and spotting. Numerous structures and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

White Sage, Arizona Strip District, BLM. CIMT (GB Team 6). Fifteen miles southeast of Fredonia, AZ. Timber and brush. Extreme fire behavior with running, wind-driven runs and short crown runs. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Deer Creek, Southeast Area, Utah DOF. CIMT (GB Team 4). Twenty-five miles southeast of Moab, UT. Timber, chaparral and brush. Minimal fire behavior with creeping, smoldering and flanking. Several communities threatened. Evacuations, area, road and trail closures in effect.

Forsyth, Dixie NF, USFS. Transfer of command from CIMT (GB Team 2) back to the local unit will occur tomorrow. Thirty miles north of St. George, UT. Timber and brush. Minimal fire behavior with creeping and smoldering. Numerous structures and energy infrastructure threatened. Area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

Hot Canyon, Elko District, BLM. Ten miles northwest of Montello, NV. Timber, brush and grass. Minimal fire behavior with creeping and smoldering. Structures and sage-grouse habitat threatened.

Cornucopia, Elko District, BLM. Sixteen miles north of Tuscarora, NV. Brush and grass. Minimal fire behavior with smoldering and creeping.

*** Diamond Canyon**, Desert Rivers Fire and Aviation Management Unit, BLM. Thirty-nine miles northeast of Moab, UT. Timber and brush. Minimal fire behavior with creeping and backing.

Big Bear, Payette NF, USFS. Previously reported incident. Fifty-nine miles northwest of McCall, ID. Timber and brush. Moderate fire behavior with flanking, backing and creeping. Residences threatened. Last narrative report unless significant activity occurs.

Cram, Prineville District, BLM. CIMT (NW Team 10). Fifteen miles north of Madras, OR. Grass, brush and timber. Active fire behavior with wind-driven runs, running and short-range spotting. Numerous residences threatened. Evacuations and road closures in effect.

Hope, Northeast Region, Washington DNR. CIMT (NW Team 8). Started on private land 15 miles north of Kettle Falls, WA. Timber and brush. Active fire behavior with wind-driven runs, group torching and spotting. Numerous structures threatened. Area, road and trail closures in effect.

Elk, Klamath Unit, Oregon DOF. CIMT (ODF Team 1). CIMT is also managing the Hagelstein incident. Seven miles southwest of Beatty, OR. Timber and closed timber litter. Moderate fire behavior with smoldering. Numerous structures and energy infrastructure threatened. Area and road closures in effect.

Hagelstein, Klamath Unit, Oregon DOF. Four miles southeast of Modoc Point, OR. Timber and light slash. Active fire behavior with flanking, single tree torching and spotting. Energy infrastructure threatened. Area and road closures in effect.

Pomas, Okanogan-Wenatchee NF, USFS. CIMT (NW Team 12). Thirty-six miles northwest of Entiat, WA. Grass and timber. Active fire behavior with backing, creeping and torching. Area, road and trail closures in effect.

Grizzly Complex, Medford Unit, Oregon DOF. CIMT (ODF Team 3). Twenty miles west of Medford, OR. Timber and brush. Minimal fire behavior with smoldering. Road closures in effect.

Bear Gulch, Olympic NF, USFS. Ten miles northwest of Hoodport, WA. Timber. Active fire behavior with isolated torching. Area, road and trail closures in effect.

Western Pines, Northeast Region, Washington DNR. Started on private land 10 miles north of Davenport, WA. Closed timber litter and timber. Minimal fire behavior with creeping and smoldering. Structures threatened. Area, road and trail closures in effect.

Highland, Prineville District, BLM. Started on private land one mile south of Prineville, OR. Brush and grass. Minimal fire behavior with smoldering and creeping. Last report unless significant activity occurs.

Greenacres, Northeast Region, Washington DNR. Started on county land five miles north of Omak, WA. Grass and brush. No new information.

Road, area and trail closures in effect.

Wright Draw, Grand Junction Field Office, BLM. Eight miles northeast of Gateway, CO. Brush and timber. Moderate fire behavior with flanking and backing. Area, trail and road closures in effect.

South Rim, Black Canyon of the Gunnison NP, NPS. CIMT (RM Team 3). Nine miles east of Montrose, CO. Brush, timber and grass. Extreme fire behavior with uphill runs, torching and spotting. Structures threatened. Evacuations, area, road and trail closures in effect.

Ute 63, Ute Mountain Ute Agency, BIA. CIMT (CA Team 2). Seven miles southwest of Red Mesa, CO. Brush, grass and timber. Moderate fire behavior with backing, creeping and smoldering. Structures threatened.

Predictive Services Discussion:

Cascade Gap winds will increase today as an upper-level low deepens over British Columbia, boosting westerly flow throughout the northwestern United States. Westerly wind gusts of 25-35 mph will be common, while gusts through the Columbia River Gorge could locally exceed 40 mph. RH east of the Cascades will generally bottom out from 10-20%. These elevated fire weather conditions may affect far northern California into northwest Nevada, as well, where RH will locally drop to as low as 5% east of the Sierra Front.

An upper low will continue to lift north through the Southwest, drawing monsoonal moisture into the Four Corners. RH will be higher than the last few days, generally no lower than 20-30%. Thunderstorms will increase from the eastern Basin into western Colorado and most of New Mexico as a result but will likely be on the wetter side as compared to previous days, and flash flooding concerns may increase for existing burn scars. Isolated dry thunderstorms will affect areas fringed by the deeper moisture, from northern Nevada and Utah into eastern Idaho and western Wyoming. These areas will otherwise hot, breezy and dry, and erratic outflow winds may gust as high as 40-50 mph. Some drier air will be pulled into southern parts of Arizona and California, but a few mixed wet/dry storms may pop up again over the Southern California mountains.

Flash flooding will be likely along parts of the central Gulf Coast as the remnant tropical disturbance lingers. Showers and thunderstorms will continue near a stationary front draped from the Mid-Mississippi Valley to the Mid-Atlantic, with thunderstorms returning to the Upper Midwest ahead of the next front. The Northeast will be dry and pleasant, while hot, dry and breezy conditions continue over the Southern Plains.
