Predictive Services Discussion:

Enhanced westerly flow will continue from the Northwest into Idaho and the northern Rockies today, resulting in widespread wind gusts of 25-35 mph and local terrain-enhanced gusts near 50 mph. The Columbia Basin will see increased Pacific moisture and higher humidity compared to Friday, but areas farther south and east will see minimum humidity as low as 10-15%, locally near 5% across Nevada and northeast California. Tomorrow's setup will result in areas of elevated fire weather across northern Nevada and much of southeastern Idaho, potentially allowing for lightning holdovers to emerge from the past week. Improved humidity in the Columbia Basin will be somewhat offset by winds that remain gusty, especially through the Cascade gaps. Temperatures will drop a few degrees to near average over most of the Northwest, but downslope winds will bring a sizable warmup to areas east of the Divide in Wyoming and Montana.

Residual but decreasing monsoonal moisture will maintain a chance for isolated to widely scattered mixed wet/dry thunderstorms from the southern Sierra through the southern and eastern Great Basin, possibly extending into the West Slope. Thunderstorms should be wetter but more widely scattered from far eastern Arizona into New Mexico and southern/eastern Colorado. Triple-digit high temperatures will expand from previous days in the deserts as monsoonal moisture decreases, with humidity as low as 5-15% for the Lower Colorado Basin.

The remnants of the northern Gulf tropical disturbance will maintain showers and thunderstorms capable of producing flash flooding from far eastern Texas into the Lower Mississippi Valley, with some of this moisture feeding into a front in the Great Lakes and Appalachian states. Severe storms are expected in the Midwest and parts of the northern High Plains. Hot and dry conditions will affect the rest of the coastal Southeast, in addition to the Southern Plains. Highs will rebound into the 70s and low 80s across the Alaska Interior, but relative humidity is forecast to remain above 35%.
