Predictive Services Discussion:

Drier west-southwesterly flow will encompass much of the Intermountain West today, with broad upper-level troughing expanding across the northwestern United States and Canada. This pattern change marks the beginning of a few days of accelerated drying, potential lightning holdover emergence and wind-driven fire growth in the region. Temperatures will be close to seasonal norms in most of the West.

Thunderstorm coverage will decrease over the Southwest as deeper monsoonal moisture is swept out of the region, with mixed wet/dry thunderstorms scattered this afternoon over the Rim into the mountains of New Mexico and southern Colorado. Farther north, fast-moving thunderstorms could lead to some new ignitions and gusty outflow winds over the northern Rockies. Humidity in most of the Intermountain West will be lower than previous days, reaching as low as 3-8% across Nevada and 10-15% in many areas. The Northwest and northern Great Basin will see a milder and more humid day, however. Westerly Cascade Gap winds will persist but trend lower than previous days. Elevated to locally critical fire weather conditions are likely from northeastern California into the Great Basin, with wind gusts reaching 20-35 mph during the afternoon and locally over 40 mph east of the Sierra. Terrainenhanced gusts from eastern Idaho through central Wyoming could be as high as 45-55 mph.

Severe thunderstorms and flash flooding will be possible from the Dakotas through the Mid-Atlantic states. Look for continued hot, dry and breezy conditions in the Southern Plains. The Great Lakes will be dry and pleasant, while showers and thunderstorms are expected along a passing front in the Northeast. Moisture will increase with light rain moving into western Alaska, but the eastern Interior will remain warm and dry, with humidity falling to near 25% for a few hours.
