Predictive Services Discussion:

An upper-level trough is forecast to dig into the Northwest today, which will enhance southwesterly flow across the rest of the Intermountain West. Critical fire weather is likely from far northeastern California into northwestern and eastern Nevada, with more widespread elevated conditions in neighboring states. A resurgence of monsoonal moisture is expected to bring a slight increase in thunderstorms to the Four Corners.

Southwest winds will be strongest from the lee of the northern Sierra into most of the Great Basin, with gusts from 25-40 mph common amid RH as low as 5-15%. Localized downslope gusts to 50 mph are possible. Winds in the Southwest will be on the increase, as well. This pattern overall may lead to lightning holdover fires emerging across the central and southern Intermountain West, with growth on established fires more likely than over the weekend.

Scattered mixed wet and dry storms will erupt across eastern Utah and Arizona into Colorado and New Mexico, potentially leading to new lightning ignitions and erratic outflow winds. Meanwhile, the Northwest and northern Rockies will be unusually cool, with temperatures as much as 15-25 degrees below average. Showers and a few embedded storms are expected under the upper trough, especially over the mountains.

Look for above average temperatures across the Southern Area, while the Great Lakes and Northeast will be unusually cool. Alaska's central and eastern Interior will see increasing rain chances and higher humidity.
