**Burdoin**, Southeast Region, Washington DNR. CIMT (NW Team 13). Five miles west of Lyle, WA. Timber and grass. Moderate fire behavior with flanking, backing and uphill runs. Numerous structures and infrastructure threatened. Evacuations, area and road closures in effect.

**Lake Spokane**, Northeast Region, Washington DNR. CIMT (NW Team 2). Started on private land 12 miles northwest of Spokane, WA. Timber and brush. Moderate fire behavior with flanking, backing and creeping. Numerous structures and communication infrastructure threatened. Road closures in effect.

**Butte Creek**, Warm Springs Agency, BIA. CIMT (NW Team 3). CIMT is also managing the Cram incident. Five miles northeast of Simnasho, OR. Grass, timber and brush. Minimal fire behavior with creeping and smoldering. Structures threatened. Evacuations, area and road closures in effect.

#### **Predictive Services Discussion:**

The base of an upper-level trough will begin to cut off and drift off the coast of California today, allowing high pressure to build across most of the West, promoting a warming and drying trend. Monsoonal moisture will be shunted to the east as dry and breezy conditions expand over the Desert Southwest. Alaska will continue to be showery and cool.

Elevated fire weather will be possible from the east slopes of the southern Sierra into southern Nevada and the Four Corners, where southwest wind gusts from 20-40 mph are expected and RH will be as low as 5-15%. Seasonably warm to above average temperatures returning to the northwestern U.S. will be accompanied by RH as low as 15-25% east of the Cascades. Westerly Cascade gap winds will increase late this afternoon, but gusts should be no higher than 30 mph. A few dry thunderstorms may pop up over northern California and Nevada from late this afternoon into tonight, but coverage will be limited.

Monsoonal showers and thunderstorms will be concentrated along and east of the Divide in New Mexico and Colorado, with wet weather extending east throughout the High Plains from Montana to West Texas. Isolated dry thunderstorms will be possible over the Mogollon Rim and Wasatch during the afternoon. Severe thunderstorms and flash flooding will be likely over the Upper Midwest ahead of a slow-moving cold front. Weak low pressure in the northeastern Gulf is not expected to become tropical but will maintain chances for heavy rain in portions of the Southeast as it moves slowly to the west. Meanwhile, drier air in the Northeast will expand into the Carolinas.
