Predictive Services Discussion:

Abundant lightning and erratic outflow winds will accompany thunderstorm activity in parts of the northwestern U.S. again today. Temperatures will trend above average throughout most of the Rocky Mountains with a notable decrease in monsoonal moisture and cloudiness, while readings will be near to below average closer to the West Coast. Otherwise, breezy conditions and a persistently bone-dry air mass will maintain accelerated drying of fuels in the Intermountain West. Heavy rain and a few severe storms will affect the Gulf Coast and areas along a front from the Central Plains to New England.

Isolated dry thunderstorms will spread to the northwest from the central Sierra into northern California this morning, before becoming much more numerous and trending wetter in the afternoon. Mixed wet/dry thunderstorms will extend into the rest of northern Nevada, southeast Oregon, southwest through central Idaho and southwest Montana this afternoon and evening, as well. Cloud-to-ground lightning counts will trend higher than on Thursday. Isolated dry thunderstorms are also expected either side of the Divide in Colorado and northern New Mexico, with most of the wetter storms and deeper monsoonal moisture drifting east of there into the High Plains from Montana to West Texas.

Poor moisture recovery in the central and southern Intermountain West will lead to an afternoon with widespread single-digit minimum humidity values. Most of the region will also see the start of a breezier period, with southwesterly gusts from 25-40 mph resulting in wind-driven fire growth. Ventilation rates will increase for established large fires from northern Arizona into Utah, while lightning holdover fires could emerge in these conditions, as well. Meanwhile, westerly Cascade gap winds gusting from 30-40 mph will persist in the Northwest, where temperatures will be a few degrees milder than today. Fire concerns will be low throughout Alaska.
