Cumulative acres showing in the Active Incident Resource Summary Table may not be reflected in the YTD statistics due to a lag in units completing YTD adjustments in the SIT/209 Application. Otherwise, changes in agency YTD fires and acres reflect more accurate mapping or reporting adjustments.

Predictive Services Discussion:

Hot, dry and windy conditions will dominate the intermountain West with temperatures above 100°F in the lower elevations of the Southwest and southern California. Above normal temperatures combine with relative humidity as low as 5 – 15% and strong westerly surface wind to create elevated fire weather conditions over the southern half of the Great Basin and the greater Four Corners Region, with a smaller area in southeast Nevada, southwest Utah and far northwest Arizona reaching critical conditions due 20-30 mph winds, gusting to 40 mph. Breezy conditions are likely to extend across the Great Basin and into western New Mexico. Isolated to scattered afternoon showers and thunderstorms are likely in the high elevations of northern California into the Central Idaho Mountains and western Montana, while higher coverage for rain and thunderstorms extends across the Northern Rockies into the Great Lakes Region and south into the Central Plains. A chance of severe thunderstorms will develop along a cold front from northeast Wyoming into the Middle Mississippi Valley. Isolated to scattered showers are likely across most of the southeastern United States today, with areas of heavy rain over the Mid-Atlantic, the Ohio and Tennessee Valleys. Warm and dry conditions will continue across much of Alaska, with breezy easterly winds over the interior, as well as thunderstorm potential in the southwest Interior.
