* **Alder Springs**, Ochoco NF, USFS. Eight miles northwest of Terrebonne, OR. Timber, grass and brush. Extreme fire behavior with wind-driven runs, uphill runs and spotting. Numerous structures threatened. Evacuation and road closures in effect.

Pomas, Okanogan-Wenatchee National Forest, USFS. Thirty-seven miles northwest of Entiat, WA. Heavy slash and brush. Active fire behavior with long-range spotting, torching and wind-driven runs. Area and trail closures in effect.

Ferry, Prineville District, BLM. Eleven miles east of Moro, OR. Grass and chaparral. Minimal fire behavior with backing. Structures and energy infrastructure threatened. Last report unless significant activity occurs.

Cumulative acres showing in the Active Incident Resource Summary Table may not be reflected in the YTD statistics due to a lag in units completing YTD adjustments in the SIT/209 Application. Otherwise, changes in agency YTD fires and acres reflect more accurate mapping or reporting adjustments.

Predictive Services Discussion:

Westerly wind, with sustained speeds of 20 mph, gusting to 30-40 mph, is expected over the greater Four Corners region today, where temperatures will continue to be up to 5 degrees above normal, and relative humidity will reach the single digits, creating elevated to critical fire weather conditions. Strong westerly flow over warm and dry conditions is also likely in the far eastern Great Basin, Western Slopes of the Rockies, eastern slopes of the Cascades, Columbia Basin and the Southern Plains. Conversely, temperatures in the Lower Mississippi Valley through the Atlantic Coast States will be up to 10°F below normal under southwesterly flow today, and moisture from the Gulf will bring isolated to scattered showers and thunderstorms to the area. Heavy rain and potentially flash flooding are possible in the southern Ohio Valley and also in the Middle Mississippi Valley. An area of high potential for severe thunderstorms exists in the Central Plains. Above normal temperatures with relative humidity reaching the twenties are expected across the interior of Alaska today with the possibility of isolated thunderstorms in the eastern Interior, and scattered thunderstorms likely in the western Interior and parts of the Southwest.
