Predictive Services Discussion:

High pressure quickly rebuilds over the West today, bringing temperatures to well above normal. Highs are expected to be above 110°F in the greater Sonora Desert Area and 0-10°F above normal in nearly all areas west of the Divide, where relative humidity will be less than 10% across the lower elevations. Winds will be primarily terrain driven and follow local patterns for much of the west, with the exception of the Northwest and Northern California ahead of another strong trough, leading to breezy westerly winds late in the day over portions of Northern California and gusty westerly winds through the Cascade Gaps, extending across the Columbia Basin. Temperatures will also reach above normal in the far Southeastern United States, with chance of isolated to scattered thunderstorms in most of the eastern States, with lowest chances over the Southern Atlantic Coast, and severe thunderstorm possible ahead of a cold front extending from the southern Great Plains into the Great Lakes Region. Alaska will continue in a hot and dry pattern, with highs in the interior reaching 80-90°F and relative humidity reaching the low twenties. Thunderstorms with little associated rainfall are forecast for the Middle Tanana Valley, with scattered mixed wet and dry thunderstorms likely across the Interior.
