Predictive Services Discussion:

The Eastern United States will continue to experience well above normal temperatures today, with highs near or above 90°F forecast for nearly all areas east of the Divide. In the West, a low-pressure trough is causing temperatures to be unseasonably cool: areas of the Northwest are expecting high temperatures in the 60s or below. Scattered showers thunderstorms will move across the Northwest through Montana where elevations above 6,000 ft may receive snow. Prefrontal, southwest winds will form ahead of the trough over the Southwest, eastern Great Basin, Southwestern Wyoming and the West Slopes of Colorado. Relative humidity is also expected to be low in these areas, creating elevated to critical fire weather conditions. Similar conditions are anticipated in the California Central Valley, where north winds will be 15-20 mph. Isolated to scattered thunderstorms are also forecast for southeastern New Mexico and the Gulf Coast with more widespread, potential severe thunderstorms over the Great Lakes into the Northern Atlantic. Above normal temperatures will persist across Alaska and scattered wet and dry thunderstorms are expected in the northeast Interior this afternoon.
