Bear Creek, Fairbanks Area, Alaska DOF. CIMT (AK Team 1) mobilizing. Started on private land 14 miles northwest of Healy, AK. Timber. Extreme fire behavior with flanking and running. Structures threatened. Evacuations in effect.

Aggie Creek, Fairbanks Area, Alaska DOF. Started on state land 23 miles northwest of Fairbanks, AK. Timber. Extreme fire behavior. Residences threatened.

Nelchina Glacier, Valdez-Copper River Area, Alaska DOF. One hundred twenty-eight miles north of Copper River, AK. Timber. Active fire behavior with torching and group torching. No new information.

Oskawalik, Southwest Area, Alaska DOF. Nine miles south of Crooked Creek, AK. Timber. Minimal fire behavior. Residences threatened.

Bonnifield Creek, Fairbanks Area, Alaska DOF. Thirty-three miles southwest of Salcha, AK. Timber and grass. Extreme fire behavior with crowning. Residences threatened. Evacuations in effect.

* **Ptarmigan Complex** (2 fires), Upper Ukon Zone, BLM. Two miles southeast of Central, AK. Brush and timber. Extreme fire behavior with running, torching and crowning.

* **Lush**, Tanana Zone, BLM. Started on private land 4 miles west of Rampart, AK. Timber and hardwood litter. Active fire behavior with wind driven runs. Structures threatened. Last narrative report unless significant activity.

Predictive Services Discussion:

A powerful heat wave will continue to impact the Eastern United States today, with highs above 90°F forecast for nearly all areas east of the Divide and in the Desert Southwest. Showers and thunderstorms will impact the Northern Atlantic States. Over the West, a low-pressure trough is keeping temperatures unseasonably cool: areas of the Northwest, northern Great Basin and across the Northern Rockies are expecting high temperatures in the 60s or below with isolated showers and thunderstorms. Isolated to scattered thunderstorms are also forecast for southeastern New Mexico, far west Texas, and the Gulf Coast, with more widespread and wetter storms over the North/Central Great Plains into the Great Lakes. Strong southwest winds will form ahead of the trough over the Southwest, and the West Slopes of Colorado into Wyoming and Idaho. Relative humidity is also expected to be in the teens, creating areas of elevated fire weather conditions. Breezy, prefrontal southerly winds will also develop across the Southern Great Plains through the Mississippi Valley. Above normal temperatures will persist across Alaska with relative humidity 20-30% and scattered wet and dry thunderstorms expected in the far northeast Interior.
