**Himalaya Road**, Fairbanks Area, Alaska DOF. CIMT (SW Team 3). CIMT is also managing the Aggie Creek incident. Started on Alaska DNR land 12 miles northwest of Fox, AK. Grass and timber. Active fire behavior with uphill runs, group torching and long-range spotting. Numerous residences threatened. Evacuations and road closures in effect.

**Aggie Creek**, Fairbanks Area, Alaska DOF. Started on Alaska DNR land 23 miles northwest of Fairbanks, AK. Timber. Moderate fire behavior. Residences threatened. Road closures in effect.

**Bear Creek**, Fairbanks Area, Alaska DOF. CIMT (AK Team 1). Started on Alaska Native Corporation land 14 miles northwest of Healy, AK. Timber. Moderate fire behavior with single tree torching. Structures threatened. Evacuations and road closures in effect.

**Seven Mile Lookout**, Tok Area, Alaska DOF. Started on Alaska DNR land seven miles southwest of Tok, AK. Timber. Moderate fire behavior. Residences threatened. Evacuations in effect.

**Nelchina Glacier**, Valdez-Copper River Area, Alaska DOF. One hundred twenty-eight miles north of Copper River, AK. Timber. Active fire behavior with wind driven runs and short crown runs. Structures threatened.

\* **Richards**, Galena Zone, BLM. Started on FWS land 10 miles west of Huslia, AK. Timber. Minimal fire behavior with smoldering. Precipitation occurred over the fire area yesterday.

\* **Saint George Creek**, Fairbanks Area, Alaska, DOF. Includes the acreage from the previously reported Bonnifield Creek fire. Started on Alaska DNR land 30 miles southwest of Salcha, AK. Timber. Moderate fire behavior. Structures threatened. Evacuations and road closures in effect.

**Ptarmigan Complex** (3 fires), Upper Yukon Zone, BLM. Two miles southeast of Central, AK. Brush and timber. Active fire behavior with running, backing and smoldering. Residences threatened.

## **Predictive Services Discussion:**

A trough over the West Coast will keep temperatures in southern California, the Southwest, and the Great Basin up to 10°F below normal, while the Pacific Northwest, northern California, and the northern Rockies will experience near to above normal temperatures. Southerly flow into the Southwest will continue, with precipitation and thunderstorm coverage expanding a bit farther west of the Divide in western New Mexico. Arizona and the eastern Great Basin will see south/southwest winds, sustained at 10-15 mph with gusts near 25, creating elevated fire weather conditions.

The ridge of high pressure will maintain above normal temperatures across the eastern states, although the heat wave will become less expansive. Highs near or above 100°F will occur along the central and north Atlantic Coast and New England, while the Southeast, Midwest, and Great Plains cool closer to normal, in the 80s and 90s. The central and northern Great Plains will have a cooler day due to widespread cloud cover and thunderstorms that will extend into eastern Wyoming. Isolated thunderstorms are also possible for the eastern Sierra, northeast Nevada, and northern Utah.
