**Bear Creek**, Fairbanks Area, Alaska DOF. CIMT (AK Team 1). CIMT is also managing the Saint George Creek incident. Started on Alaska Native Corporation land 14 miles northwest of Healy, AK. Timber. Minimal fire behavior with creeping and smoldering. Structures threatened. Evacuations in effect.

**Saint George Creek**, Fairbanks Area, Alaska, DOF. Started on Alaska DNR land 30 miles southwest of Salcha, AK. Timber. Minimal fire behavior. Structures threatened.

**Roundabout Complex** (4 fires), Galena Zone, BLM. Started on FWS land 8 miles southwest of Huslia, AK. Timber and brush. Moderate fire behavior with creeping and smoldering. Structures threatened. Precipitation occurred over the fire area yesterday.

**Ptarmigan Complex** (4 fires), Upper Yukon Zone, BLM. Two miles south of Central, AK. Brush, timber and hardwood litter. Minimal fire behavior with smoldering and creeping. Numerous residences threatened. Area closures in effect. Precipitation occurred over the fire area yesterday.

## **Predictive Services Discussion:**

Upper-level westerly flow and an associated cold front will continue to bring breezy westerly winds to the Cascade Gaps and Colombia Basin, spreading into the northern Great Basin. Sustained winds of 12-25 mph with gusts to 35 mph are expected, creating locally elevated conditions as RH falls to 8-20%. Isolated, mainly wet, thunderstorms will develop along the front across Montana. Lighter westerly winds of 10-15 mph will spread across the southern/eastern Great Basin, Arizona, and West Slope as very low RH of 4-12% continues and poor overnight recovery. Monsoon moisture will slowly wane in New Mexico, with isolated to scattered showers and thunderstorms in southeast Arizona into southern and eastern New Mexico.

Above normal temperatures will continue across the Southeast, and another day of scattered showers and thunderstorms is expected. While some areas will receive wetting rain, others will remain dry especially along the southeast Atlantic coast. The heat will continue to wane in the Mid-Atlantic and Northeast due to a cold front, with scattered showers and thunderstorms. Scattered to widespread showers and thunderstorms are also expected along a cold front from the central Plains to the Great Lakes. Cool and moist conditions will continue across Alaska, with fewer showers.
