**Himalaya Road**, Fairbanks Area, Alaska DOF. CIMT (SW Team 3). CIMT is also managing the Aggie Creek incident. Started on Alaska DNR land 12 miles northwest of Fox, AK. Chaparral and timber. Minimal fire behavior with smoldering. Numerous residences threatened. Road closures in effect. Reduction in acreage due to more accurate mapping.

**Aggie Creek**, Fairbanks Area, Alaska DOF. Started on Alaska DNR land 23 miles northwest of Fairbanks, AK. Chaparral and timber. Minimal fire behavior with smoldering. Residences threatened. Road closures in effect.

**Bear Creek**, Fairbanks Area, Alaska DOF. CIMT (AK Team 1). CIMT is also managing the Saint George Creek incident. Started on Alaska Native Corporation land 14 miles northwest of Healy, AK. Timber. Moderate fire behavior with running, creeping and smoldering. Numerous structures threatened. Area and trail closures in effect.

**Saint George Creek**, Fairbanks Area, Alaska, DOF. Started on Alaska DNR land 30 miles southwest of Salcha, AK. Timber. Minimal fire behavior with creeping and smoldering. Structures threatened.

**Ptarmigan Complex** (4 fires), Upper Yukon Zone, BLM. Two miles south of Central, AK. Brush, timber and hardwood litter. Minimal fire behavior with smoldering and creeping. Numerous residences threatened. Area closures in effect.

**Seven Mile Lookout**, Tok Area, Alaska DOF. Started on Alaska DNR land seven miles southwest of Tok, AK. Timber. Moderate fire behavior with torching. Residences threatened.

## **Predictive Services Discussion:**

Locally breezy westerly sustained winds of 12-20 mph with gusts to 30 mph are expected in the Columbia Basin to the northern Great Basin this afternoon, creating locally elevated conditions as relative humidity falls to 8-20%. Stronger westerly winds of 15-25 mph with gusts to 40 mph are expected in southwest Wyoming for more widespread elevated conditions. Lighter westerly winds of 10-15 mph will continue across the southern/eastern Great Basin, Arizona, and West Slope amid very low relative humidity of 4-12%. Moisture will continue to slowly wane in New Mexico, with isolated showers and thunderstorms mainly east of the Divide.

Above normal temperatures will continue across the Southeast, with fewer thunderstorms than observed recently, with the Carolina Coast likely to remain dry. Scattered showers and thunderstorms are expected to develop across much of the central and northern Plains into the Ohio Valley and Northeast, with heavy rain likely in northern New England. Temperatures are expected to remain near normal in Alaska, with fewer showers than previous days.
