Cumulative acres showing in the Active Incident Resource Summary Table may not be reflected in the YTD statistics due to a lag in units completing YTD adjustments in the SIT/209 Application. Otherwise, changes in agency YTD fires and acres reflect more accurate mapping or reporting adjustments.

#### **Predictive Services Discussion:**

Locally breezy westerly winds will spread across the eastern Great Basin, Wyoming, West Slope, and northern Arizona tomorrow with sustained winds of 12-20 mph and gusts to 30 mph amid relative humidity of 5-20%, lowest in the Greater Four Corners. Stronger west winds of 15-25 mph gusting to 40 mph are expected in the Upper Snake River Plain into western Wyoming for elevated fire weather conditions. Lighter winds and more moderate relative humidity of 12-25% are expected across the northwestern US and California. Monsoon moisture will continue to wane in New Mexico, with isolated showers and thunderstorms confined to south-central New Mexico and east of the central mountains, with relative humidity below 15% returning to all areas west of the Divide.

A cold front moving through the Northeast will bring showers and thunderstorms, with scattered showers and thunderstorms across much of Florida and the northern Gulf Coast into the Appalachians. Another cold front will bring showers and thunderstorms to the northern Plains and Upper Midwest. However, the eastern Carolinas and much of Texas will continue to remain dry, but winds will generally be light.
