**Himalaya Road**, Fairbanks Area, Alaska DOF. CIMT (SW Team 3). CIMT is also managing the Aggie Creek incident. Started on Alaska DNR land 12 miles northwest of Fox, AK. Chapparal and timber. Moderate fire behavior with flanking, isolated torching and smoldering. Numerous residences threatened. Road closures in effect. Precipitation occurred over the fire area yesterday.

**Aggie Creek**, Fairbanks Area, Alaska DOF. Started on Alaska DNR land 23 miles northwest of Fairbanks, AK. Chaparral and timber. Moderate fire behavior with flanking, isolated torching and smoldering. Residences threatened. Road closures in effect. Reduction in acreage due to more accurate mapping. Precipitation occurred over the fire area yesterday.

**Bear Creek**, Fairbanks Area, Alaska DOF. CIMT (AK Team 1). CIMT is also managing the Saint George Creek incident. Started on Alaska Native Corporation land 14 miles northwest of Healy, AK. Timber. Minimal fire behavior with backing, creeping and smoldering. Numerous structures threatened. Evacuations, area and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Saint George Creek**, Fairbanks Area, Alaska, DOF. Started on Alaska DNR land 30 miles southwest of Salcha, AK. Timber. Minimal fire behavior with creeping and smoldering. Residences threatened. Precipitation occurred over the fire area yesterday.

**Ptarmigan Complex** (4 fires), Upper Yukon Zone, BLM. Two miles south of Central, AK. Brush, timber and hardwood litter. Minimal fire behavior with smoldering and creeping. Numerous residences threatened. Area closures in effect.

**Seven Mile Lookout**, Tok Area, Alaska DOF. Started on Alaska DNR land seven miles southwest of Tok, AK. Timber. Minimal fire behavior with smoldering and single tree torching. Residences threatened. Precipitation occurred over the fire yesterday.

**Oskawalik**, Southwest Area, Alaska DOF. Nine miles south of Crooked Creek, AK. Timber. Minimal fire behavior. Residences threatened.

**Runt**, Upper Yukon Zone, BLM. Eighty-seven miles southwest of Circle, AK. Brush and timber. Minimal fire behavior. Structures threatened.

**Roundabout Complex** (3 fires), Galena Zone, BLM. Started on FWS land 8 miles southwest of Huslia, AK. Timber and brush. Moderate fire behavior. Structures threatened.

#### **Predictive Services Discussion:**

Temperatures 10-20°F are expected across much of the West today amid minimum relative humidity of 5-20%, with daily record high temperatures likely in the Southwest and southern Great Basin. Breezy southerly winds of 15-20 mph with gusts to 30 mph will develop across central and southern Nevada creating elevated conditions. Isolated to scattered mixed wet/dry thunderstorms will develop in northern California into southwest and south-central Oregon, with a few storms continuing overnight. Isolated dry thunderstorms will along the Oregon-Nevada border east into the Wasatch and Uinta Mountains, while isolated mixed wet and dry thunderstorms will develop in southeast Arizona into southwest Colorado. Isolated to scattered mixed and dry thunderstorms will develop in central and eastern New Mexico into West Texas, the Colorado Front Range, and southeast Wyoming.

A cold front extending from Oklahoma to the Great Lakes will bring scattered to widespread showers and thunderstorms from the Texas Panhandle northeast to the Great Lakes. Isolated to scattered showers and thunderstorms will continue to develop from the northern Gulf Coast and Florida into the Ohio Valley and Appalachians, but the Carolina Coast and central Texas will remain dry. The warming trend will continue across the Alaska Interior, but isolated showers and thunderstorms remain possible in the eastern Interior and eastern Brooks Range.
