Covington Drive, South Carolina Forestry Commission. CIMT (FL State Team 1). Two miles west of Myrtle Beach, SC. Southern rough. Moderate fire behavior with creeping, smoldering and isolated torching. Numerous residences threatened.

* **Blue Plateau**, Oklahoma DOF. Fourteen miles northeast of McAlester, OK. Grass and timber. Moderate fire behavior with wind-driven runs, flanking and backing. Structures threatened.

Devils Jumps, Big South Fork National River & Recreation Area, NPS. Nine miles northwest of Winfield, TN. Hardwood litter and brush. Minimal fire behavior.

* **Kenwood 9**, Tahlequah Field Office, BIA. One mile east of Kenwood, OK. Closed timber litter and hardwood litter. Moderate fire behavior with smoldering. Structures threatened.

East Parkway, Tennessee DOF. Two miles southeast of Laurel, TN. Timber. Minimal fire behavior.

Falls Dam, National Forests in North Carolina, USFS. Two miles east of Badin, NC. Timber and hardwood litter. Minimal fire behavior. Residences threatened.

Two Barrel, National Forests in Florida, USFS. Twelve miles northeast of Wewahitchk, FL. Southern rough, timber and grass. Moderate fire behavior.

NE 90th Way, Florida Forest Service. Started on private land four miles northwest of Williford, FL. Southern rough and tall grass. No new information. Last report unless new information is received.

Predictive Services Discussion:

A ridge of high pressure will continue to be the dominate influence on the weather pattern today. Some showers and thunderstorms will be lingering across the Southeastern US, along with some light precipitation starting to move into the Pacific Northwest and Northern Rockies. Winds will generally remain lighter across the country, with wind gusts of 20 to 30 mph from across the Southern Plains, through the Central Plains and into the Great Lakes, though Minnesota may see gusts into the 30s at times. Much of the Central US will see RH of 10 to 30%. The Interior of Alaska will start to see cooling today, but much of the state will remain above normal. Precipitation will continue along the Southern Coast and Southeast Alaska. Trade winds will prevail with some windward showers for Hawai'i.
