## **Predictive Services Discussion:**

A cold front will move into the southern Plains with winds becoming northwesterly but temperatures will only cool a little. Humidity will fall into the teens for northern Texas and Oklahoma with afternoon winds 15 to 25 mph. Further to the southeast the front will stall and support thunderstorms from eastern Texas into the lower Mississippi valley. A few of these thunderstorms will be severe. The central Plains will be windy behind the front with 20 to 30 mph and humidity in the teens. Winds are expected to be weaker Saturday in eastern Colorado and New Mexico though favored locations may still see wind gusts to 40 mph.

A developing storm system over the western Great Lakes will spread precipitation across Minnesota and Wisconsin into the Ohio River Valley. The southeast US will see decreased winds but they will turn southerly and bring increasing humidity with onshore flow.

A cold front will move into the Pacific Northwest bringing winds and widespread valley rain and mountain snow. California will begin to see building high pressure which will bring a strong warming trend. Hawaii will continue to be influenced by trade winds with shower activity. Alaska weather will feature normal temperatures for March with increasing precipitation along the southern coast.
