Deep Woods, North Carolina Forest Service. Four miles northeast of Saluda, NC. Hardwood litter, timber and light slash. Active fire behavior with uphill runs, running and backing. Numerous structures and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Fish Hook, North Carolina Forest Service. Five miles north of Columbus, NC. Hardwood litter, timber and light slash. Active fire behavior with uphill runs, running and backing. Structures threatened. Area, road and trail closures in effect.

* **Table Rock**, South Carolina Forestry Commission. Four miles northeast of Sunset, SC. Hardwood litter, timber and medium slash. Active fire behavior with single tree torching, uphill runs and short-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

* **Iron Circle**, North Carolina Forest Service. Six miles northeast of Morganton, NC. Hardwood litter. Active fire behavior with running. Structures threatened.

* **Old Hwy 16**, North Carolina Forest Service. Two miles southeast of Glendale Springs, NC. Hardwood litter. Active fire behavior with running. Numerous structures threatened.

* **Rock Springs**, Kentucky DOF. Five miles southeast of Williamsburg, KY. Grass and timber. Active fire behavior with running, spotting and flanking. Structures threatened.

* **Three Rivers**, Oklahoma DOF. Two miles southeast of Octavia, OK. Timber. Active fire behavior with wind-driven runs and crowning. Structures threatened.

* **Back Valley Road**, Georgia Forestry Commission. Two miles west of Lyerly, GA. Timber. Minimal fire behavior with backing. Residences threatened.

328 Road, Oklahoma DOF. Ten miles southeast of Cleveland, OK. Grass and timber. Minimal fire behavior with smoldering. Residences threatened.

344, Florida Forest Service. Seven miles east of Florida City, FL. Grass. Active fire behavior with flanking.

Oak Street, Oklahoma DOF. Four miles southeast of Cleveland, OK. Timber and grass. Minimal fire behavior with smoldering.

33 Road, Oklahoma DOF. Seven miles northeast of Arcadia, OK. Grass, brush and timber. Minimal fire behavior with smoldering.

Pauline Road, Texas A&M Forest Service. Started on private land 15 miles east of Willis, TX. Timber and southern rough. Minimal fire behavior with smoldering.

Euchee Valley, Oklahoma DOF. Four miles southwest of Cushing, OK. Grass and timber. Minimal fire behavior with smoldering.

Cumulative acres showing in the Active Incident Resource Summary Table may not be reflected in the YTD statistics due to a lag in units completing YTD adjustments in the SIT/209 Application. Otherwise, changes in agency YTD fires and acres reflect more accurate mapping or reporting adjustments.

Predictive Services Discussion:

A cold front will move off the East Coast tonight with scattered showers and isolated thunderstorms east of the Appalachians, with more widespread rain in southern New England while snow falls in northern New England. The front will stall along the Gulf Coast with locally heavier showers for the northern Gulf Coast. Behind the front, breezy and dry westerly winds of 15-25 mph with gusts to 40 mph will develop over the Ohio/Tennessee Valleys as relative humidity falls to as low as 20%. Breezy and dry southwest winds of 15-20 mph will develop as relative humidity falls to 15% in portions of Oklahoma and Kansas bringing elevated conditions. Farther north, northwest winds of 20-35 mph will develop across eastern Wyoming into the Nebraska Panhandle, but humidity is expected to remain higher.

A strong upper-level ridge in the Southwest will bring well above normal temperatures to southern California and the Southwest with minimum relative humidity of 5-15% and poor overnight recovery. Light precipitation will continue in Washington to the northern Rockies, but snow level will rise to near or above 7,000 feet, while much of the Great Basin and central Rockies warm to well above normal. Above normal temperatures and generally dry conditions will continue in Alaska, while sea breezes develop across Hawai'i with isolated showers, but more widespread showers are expected across Kauai tonight.
