Predictive Services Discussion:

A cold front will move through the Great Lakes, Ohio Valley, and Northeast with light precipitation, falling as mixed precipitation and snow in portions of the Great Lakes and Northeast. Ahead of the front, breezy southwesterly winds of 10-20 mph are expected amid relative humidity of 15-25% on the east slopes of the Appalachians to the Piedmont creating elevated conditions. Farther south, isolated thunderstorms will develop over the southern half of Florida. While most of these storms will be wet with rainfall greater than a quarter inch, lightning strikes outside the rain cores will be capable of new ignitions. Breezy and dry northwest winds will occur across the northern Plains into the Upper Midwest creating locally elevated conditions, while generally light winds occur on the southern Plains. Record high temperatures are expected in the Southwest, with very low minimum relative humidity and poor overnight recovery. Temperatures will warm to well above normal across the rest of the West, as well, but winds will remain light.

The 6 Minutes for Safety topic of the day is Terrain and Fuels Make Escape to Safety Zones Difficult.
