NIMO Team 1 mobilizing to assist with ongoing wildfire activity in the Southern Area.

Table Rock Complex (2 fires), South Carolina Forestry Commission. CIMT (SA Team 2). Four miles northeast of Sunset, SC. Timber, hardwood litter and brush. Active fire behavior with uphill runs, running, and isolated torching. Numerous structures threatened. Evacuations, area and trail closures in effect.

Black Cove, North Carolina Forest Service. CIMT (NC State Team 1). IMT is also managing the Deep Woods and Fish Hook fires. Five miles northeast of Saluda, NC. Hardwood litter, light slash and timber. Active fire behavior with uphill runs, flanking and spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Deep Woods, North Carolina Forest Service. Four miles northeast of Saluda, NC. Hardwood litter, timber and light slash. Active fire behavior with running, spotting and backing. Numerous structures and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Fish Hook, North Carolina Forest Service. Five miles north of Columbus, NC. Hardwood litter, timber and light slash. Moderate fire behavior with smoldering and creeping. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

Alarka #5, North Carolina Forest Service. Five miles south of Bryson City, NC. Hardwood litter and brush. Active fire behavior with spotting, torching and flanking. Numerous residences threatened. Evacuations and road closures in effect.

Big Ridge, Chattahoochee-Oconee NF, USFS. CIMT (SA Team 3). Eight miles northeast of Clayton, GA. Hardwood litter and timber. Active fire behavior with backing, flanking and wind-driven runs. Community of Sky Valley and communication infrastructure threatened. Area, road and trail closures in effect.

Rattlesnake Branch, North Carolina Forest Service. CIMT (SA Team 1). Eleven miles southeast of Waynesville, NC. Hardwood litter. Active fire behavior with running. Numerous residences threatened.

* **Glass Hollow**, Blue Ridge Parkway, NPS. Five miles south of Afton, VA. Hardwood litter and brush. Active fire behavior with wind-driven runs, uphill runs and short-range spotting. Structures threatened.

* **Beech Grove Lane**, Tennessee DOF. One mile west of Rocky Top, TN. Timber. Active fire behavior. Residences threatened.

* **Brown Mountain Road**, Virginia DOF. Seven miles north of Raven, VA. Timber and hardwood litter. Moderate fire behavior with flanking. Residences threatened.

Crusoe Island Road, North Carolina Forest Service. Twelve miles east of Williams, NC. Timber. Active fire behavior with creeping.

Happy Hill Road, Oklahoma DOF. Eight miles southeast of McAlester, OK. Timber and hardwood litter. Minimal fire behavior. Precipitation occurred over the fire area yesterday.

CR832, Florida Forest Service. Twelve miles southeast of Port LaBelle, FL. Timber and southern rough. Minimal fire behavior with creeping.

Lost John, Osage Agency, BIA. Six miles east of Hominy, OK. Hardwood litter and grass. No new information. Last report unless new information is received.

Salt Creek, Oklahoma DOF. Thirteen miles northeast of Sallisaw, OK. Hardwood litter. No new information. Last report unless new information is received.

Boar Creek, Osage Agency, BIA. Five miles east of Hominy, OK. Timber and grass. No new information. Last report unless new information is received.

Cumulative acres showing in the Active Incident Resource Summary Table may not be reflected in the YTD statistics due to a lag in units completing YTD adjustments in the SIT/209 Application. Otherwise, changes in agency YTD fires and acres reflect more accurate mapping or reporting adjustments.

Predictive Services Discussion:

Breezy southerly sustained winds of 10-25 mph, with higher gusts, will occur across the Lower and Mid-Mississippi Valley to East Coast. However, an increase in relative humidity is expected, with values near or above 30%, although portions of Virginia into central Pennsylvania will be lower with elevated fire weather conditions. Dry and breezy westerly winds of 15-25 mph with gusts to 40 mph amid relative humidity of 8-20% will develop across the Southwest into West Texas creating elevated to critical conditions. A strong storm will move from the central Rockies into the central Plains, with widespread precipitation in the northern and central Rockies into the Mississippi Valley and Great Lakes. Mixed precipitation and snow are expected in the Rockies and northern periphery of the storm, while severe thunderstorms are possible from eastern Kansas into the Mid-Mississippi Valley. Light southeast trade winds will continue across Hawai'i with a few windward showers, mainly on the Big Island. Dry conditions are also expected across much of Alaska, aside from scattered light rain and snow showers along the southern and western coasts.
