Cumulative acres showing in the Active Incident Resource Summary Table may not be reflected in the YTD statistics due to a lag in units completing YTD adjustments in the SIT/209 Application. Otherwise, changes in agency YTD fires and acres reflect more accurate mapping or reporting adjustments.

Predictive Services Discussion:

Dry conditions will continue in the Southwest with minimum relative humidity of 5-15% and poor overnight recovery of 20-35% on mid-slopes and ridges. Breezy west winds of 12-22 mph are expected in eastern Arizona and New Mexico, as well, creating areas of elevated conditions. Showers and thunderstorms will develop ahead of a cold front in the northern Plains to the Midwest. While the heaviest rain is expected to fall in the Dakotas, relief from the very dry conditions is expected in much of Minnesota. Farther west, scattered showers and thunderstorms will develop across the central and northern Rockies. Very hot temperatures up to 110°F will continue in southwest Texas along with minimum relative humidity in the single digits and teens. Weakening upper-level low pressure will continue to bring scattered showers to the Northeast, while drier conditions develop in the Southeast. Dry and breezy northeast winds will continue across much of Alaska today, with the strongest gusts expected in southwest Alaska. Breezy trade winds are expected across Hawai'i with generally dry conditions except for a few windward showers.
