Predictive Services Discussion:

Dry and breezy southwest winds gusting to 40 mph amid very low minimum relative humidity of 3-15% will develop across the southern Great Basin, Southwest, and West Slope through Saturday. Widespread elevated to critical conditions are expected across the Southwest where fuels are driest. Winds will diminish some on Sunday, but elevated westerly winds are likely to continue across southern New Mexico. A warming and drying trend will develop across the northern half of the West and California this weekend with temperatures rising to above normal. Widespread showers and thunderstorms will develop across much of the Plains this weekend and into the Lower/Mid-Mississippi and Tennessee Valleys. Dry conditions will persist into the weekend across most of the Southeast, but isolated to scattered thunderstorms will develop across the southern half of Florida. The Upper Midwest will remain dry through the weekend, with locally elevated conditions possible Sunday across northern Minnesota due to northerly winds amid low relative humidity. Mild and dry conditions are expected across Alaska into Saturday, with isolated thunderstorms possible late Sunday across portions of the Interior. Moist and breezy trade winds will continue across Hawai'i, with scattered to numerous showers.
