Cumulative acres showing in the Active Incident Resource Summary Table may not be reflected in the YTD statistics due to a lag in units completing YTD adjustments in the SIT/209 Application. Otherwise, changes in agency YTD fires and acres reflect more accurate mapping or reporting adjustments.

Predictive Services Discussion:

Slightly above normal temperatures are forecast throughout the West, with very dry conditions and low minimum relative humidity of 3-15% continuing for the Southwest and southern Great Basin. Breezy westerly winds of 12-20 mph will also create localized elevated conditions in the Southwest. A stalled cold front will bring widespread showers and thunderstorms to much of the central and southern Plains into the Southeast, with heavy rain and areas of flooding expected in much of Oklahoma into the Lower Tennessee Valley. Dry conditions will persist into across the Upper Midwest, but relative humidity is expected to remain near or above 30% with light winds. Showers are expected to wane across the Alaska Interior, but cool conditions and high relative humidity will persist. Dry and breezy trade winds are expected across Hawai'i.
