Lower Sugarloaf, Okanogan-Wenatchee NF, USFS. Transfer of command from CIMT (NW Team 2) to CIMT (NW Team 10) will occur today. Twelve miles northeast of Leavenworth, WA. Timber and brush. Moderate fire behavior with flanking, backing and torching. Numerous residences threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Labor Mountain, Okanogan-Wenatchee NF, USFS. CIMT (NW Team 12). Ten miles north of Cle Elum, WA. Timber and brush. Moderate fire behavior with flanking, backing and torching. Numerous residences threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Moon Complex, Rogue River-Siskiyou NF, USFS. Transfer of command from CIMT (NW Team 13) to CIMT (NW Team 7) will occur today. Eleven miles northeast of Agness, OR. Timber, closed timber litter and hardwood litter. Minimal fire behavior with smoldering, creeping and backing. Numerous structures threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Emigrant, Willamette NF, USFS. Transfer of command from CIMT (RM Team 1) back to the local unit will occur today. Twenty-four miles southeast of Oakridge, OR. Medium slash, timber and closed timber litter. Minimal fire behavior with backing, creeping and smoldering. Energy infrastructure threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Wildcat, Okanogan-Wenatchee NF, USFS. Thirty miles west of Naches, WA. Timber, brush and closed timber litter. Moderate fire behavior with single tree torching, flanking and backing. Numerous structures threatened. Area, road and trail closures in effect.

Bear Gulch, Olympic NF, USFS. Ten miles northwest of Hoodport, WA. Timber. Minimal fire behavior with backing, creeping and smoldering. Structures threatened. Evacuations, area, road and trail closures in effect.

Foley Ridge, Willamette NF, USFS. Thirty-five miles west of Bend, OR. Timber and closed timber litter. Minimal fire behavior. Structures threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Lynx Mountain, Colville Agency, BIA. Seven miles northwest of Inchelium, WA. Brush, timber and medium slash. No new information.

Cumulative acres shown in the Active Incident Resource Summary Table may not be reflected in the YTD statistics due to a lag in units completing YTD adjustments in the SIT/209 Application. Otherwise, changes in agency YTD fires and acres reflect more accurate mapping or reporting adjustments.

Predictive Services Discussion:

Isolated to scattered showers with a few thunderstorms will continue in the northwestern US, with snow possible in the higher elevations of northern California and the Cascades. Breezy west to southwest winds will develop across much of the central and western Great Basin ahead of the front, but recent rainfall will mitigate the conditions. Breezy west winds are expected across central Montana, while breezy, warm, and dry southerly winds will develop in much of western Minnesota, as well. Dry conditions will persist on the Plains and Mississippi Valley into the Great Lakes, with well above normal temperatures in the northern Plains and Great Lakes. Breezy and dry north winds will continue in the Northeast, with localized elevated conditions in Maine. Isolated showers and thunderstorms will persist in Florida, and spread into portions of the northern Gulf Coast.
