Crown Creek, Northeast Region, Washington DNR. CIMT (NW Team 12). CIMT is also managing the Blackhawk Mountain and Katy Creek incidents. Eighteen miles northeast of Kettle Falls, WA. Timber and brush. Active fire behavior with flanking, backing and single tree torching. Numerous residences threatened. Evacuations and road closures in effect.

Predictive Services Discussion:

Isolated mixed wet/dry thunderstorms with gusty outflow winds will develop again over northeast California and central Oregon, where increasing IA could result in new large fires. Another day of near record temperatures with RH values in the low teens and poor overnight recovery is expected across the Northwest and Northern Rockies creating an overall fire environment which continues to be conducive to large fire growth. Elsewhere across the interior West, warm and dry weather continues under the ridge with generally light winds. Scattered showers are possible over the southern Great Basin and Arizona.

In the Eastern US, the cold front moves into the Great Lakes bringing cooler temperatures and light showers to the area. Generally cool, dry weather is expected across Texas and along the eastern states into New England.
