**Crown Creek**, Northeast Region, Washington DNR. CIMT (NW Team 12). CIMT is also managing the Blackhawk Mountain and Katy Creek incidents. Eighteen miles northeast of Kettle Falls, WA. Timber and brush. Extreme fire behavior with group torching, short-range spotting and backing. Numerous residences threatened. Evacuations and road closures in effect.

**Blackhawk Mountain**, Northeast Region, Washington DNR. Twenty-one miles northeast of Kettle Falls, WA. Timber and brush. Extreme fire behavior with group torching, short-range spotting and flanking. Residences threatened. Evacuations and road closures in effect.

**Katy Creek**, Northeast Region, Washington DNR. Six miles northwest of Kettle Falls, WA. Timber and brush. Active fire behavior with flanking, backing and group torching. Structures threatened. Road closures in effect.

**Emigrant**, Willamette NF, USFS. CIMT (NW Team 13). Twenty-two miles southeast of Oakridge, OR. Medium slash, timber and closed timber litter. Active fire behavior with torching, flanking and uphill runs. Energy infrastructure threatened. Area, road and trail closures in effect.

**Wildcat**, Okanogan-Wenatchee NF, USFS. CIMT (NW Team 10). Thirty miles west of Naches, WA. Timber, brush and closed timber litter. Active fire behavior with short crown runs, group torching and short-range spotting. Structures threatened. Area, road and trail closures in effect.

**Lower Sugarloaf**, Okanogan-Wenatchee NF, USFS. CIMT (NW Team 3). Seventeen miles northwest of Entiat, WA. Timber and brush. Extreme fire behavior with long-range spotting, torching and crowning. Structures threatened.

**Rattlesnake**, Colville Agency, BIA. CIMT (NW Team 7) mobilizing. Two miles west of Seven Bays, WA. Grass, timber and brush. Extreme fire behavior with crowning, running and long-range spotting. Residences threatened. Area, road and trail closures in effect.

**Flat**, Sisters Unit, Oregon DOF. Transfer of command from CIMT (ODF Team 3) back to the local unit will occur today. Seven miles west of Culver, OR. Grass and brush. Minimal fire behavior with smoldering. Numerous structures threatened.

**Tacoma Creek**, Northeast Region, Washington DNR. Started on private land 19 miles east of Colville, WA. Timber, brush and light slash. Active fire behavior with short-range spotting, group torching and uphill runs. Structures threatened. Area and road closures in effect.

**Pomas**, Okanogan-Wenatchee NF, USFS. Thirty-six miles northwest of Entiat, WA. Grass, timber and light slash. Minimal fire behavior with smoldering. Communication infrastructure threatened. Area, road and trail closures in effect.

**Martin**, Okanogan-Wenatchee NF, USFS. Forty-five miles northwest of Chelan, WA. Timber and brush. Moderate fire behavior with single tree torching and backing. Structures threatened. Area and trail closures in effect.

**Perry**, North Cascades NP, NPS. Sixteen miles northeast of Newhalem, WA. Timber. Active fire behavior with backing, uphill runs and short crown runs. Area and trail closures in effect.

**Log**, Klamath NF, USFS. Eighteen miles west of Etna, CA. Timber and brush. Moderate fire behavior with backing, flanking and creeping. Area closure in effect. Precipitation occurred over the fire area yesterday.

## **Predictive Services Discussion:**

Isolated to scattered mixed wet and dry thunderstorms will develop across the Oregon Cascades and eastern Oregon south into northern Nevada and northeast Oregon. Hot, dry, and unstable conditions will persist across much of Washington into western Montana with relative humidity as low as 10% and poor overnight recovery for mid-slopes and ridges. Isolated, mainly dry, thunderstorms are possible along the east slopes of the Washington Cascades late in the afternoon. Scattered wet thunderstorms will develop in the southern Great Basin to Arizona and Four Corners.

A strong cold front will move through the northern Plains, with strong northwest winds 20–30 mph with gusts to 50 mph behind it and relative humidity as low as 25%. This front will also create locally breezy northeast winds west of the Continental Divide in western Montana. Scattered to widespread showers and thunderstorms are expected ahead of the front in the Great Lakes to the central Appalachians and New York. Freezing temperatures and areas of front are expected overnight in northern Minnesota and the Upper Great Lakes. Scattered showers and thunderstorms will persist in Florida while dry conditions continue in the rest of the Southeast.
