**Lower Sugarloaf**, Okanogan-Wenatchee NF, USFS. CIMT (NW Team 3). CIMT is also managing the Labor Mountain incident. Seventeen miles northwest of Entiat, WA. Timber and brush. Extreme fire behavior with short-range spotting, group torching and crowning. Structures threatened. Evacuations, road and trail closures in effect.

\* **Labor Mountain**, Okanogan-Wenatchee NF, USFS. Ten miles north of Cle Elum, WA. Timber. Active fire behavior with flanking, backing and group torching. Structures threatened.

**Rattlesnake**, Colville Agency, BIA. CIMT (NW Team 7). CIMT is also managing the Lynx Mountain incident. Two miles west of Seven Bays, WA. Grass, timber and brush. Extreme fire behavior with long-range spotting, short crown runs and wind-driven runs. Residences threatened. Evacuations, area, road and trail closures in effect.

**Lynx Mountain**, Colville Agency, BIA. Twenty-nine miles west of Chewelah, WA. Timber and medium slash. Active fire behavior with short crown runs, uphill runs and spotting. Numerous residences threatened. Evacuations in effect.

**Mark's Creek**, Ochoco NF, USFS. CIMT (ODF Team 2). Eighteen miles east of Prineville, OR. Timber. Active fire behavior with backing, spotting and wind-driven runs. Residences and energy infrastructure threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

**Crown Creek**, Northeast Region, Washington DNR. CIMT (NW Team 12). CIMT is also managing the Blackhawk Mountain and Katy Creek incidents. Eighteen miles northeast of Kettle Falls, WA. Timber and brush. Extreme fire behavior with group torching, short-range spotting and flanking. Numerous residences threatened. Evacuations and road closures in effect.

**Blackhawk Mountain**, Northeast Region, Washington DNR. Twenty-one miles northeast of Kettle Falls, WA. Timber and brush. Active fire behavior with group torching, short-range spotting and flanking. Residences threatened. Evacuations and road closures in effect.

**Katy Creek**, Colville NF, USFS. Six miles northwest of Kettle Falls, WA. Timber and brush. Active fire behavior with spotting, flanking and backing. Structures threatened. Road closures in effect.

**Wildcat**, Okanogan-Wenatchee NF, USFS. CIMT (NW Team 10). Thirty miles west of Naches, WA. Timber, brush and closed timber litter. Active fire behavior with short crown runs, group torching and short-range spotting. Structures threatened. Area, road and trail closures in effect.

**Emigrant**, Willamette NF, USFS. CIMT (NW Team 13). Twenty-two miles southeast of Oakridge, OR. Medium slash, timber and closed timber litter. Active fire behavior with torching, flanking and uphill runs. Energy infrastructure threatened. Area, road and trail closures in effect.

**Tacoma Creek**, Northeast Region, Washington DNR. Started on private land 19 miles east of Colville, WA. Timber, brush and light slash. Active fire behavior with long-range spotting, group torching and uphill runs. Structures threatened. Road closures in effect.

**Pomas**, Okanogan-Wenatchee NF, USFS. Thirty-six miles northwest of Entiat, WA. Grass, timber and light slash. Minimal fire behavior with smoldering. Communication infrastructure threatened. Area, road and trail closures in effect.

**Martin**, Okanogan-Wenatchee NF, USFS. Forty-five miles northwest of Chelan, WA. Timber and brush. Moderate fire behavior with single tree torching and backing. Structures threatened. Area and trail closures in effect.

**Bear Gulch**, Olympic NF, USFS. Ten miles northwest of Hoodspport, WA. Timber. Active fire behavior with flanking, creeping and isolated torching. Residences threatened. Evacuations, area, road and trail closures in effect.

**Flat**, Sisters Unit, Oregon DOF. Seven miles west of Culver, OR. Grass and brush. Minimal fire behavior. Numerous structures threatened.

\* **Bridge**, Malheur NF, USFS. CIMT (CA Team 4). Thirty-nine miles southwest of Baker City, OR. Timber and medium slash. Extreme fire behavior with group torching, flanking and running. Residences and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

\* **Moon Complex** (2 fires), Rogue River-Siskiyou NF, USFS. CIMT (GB Team 5) mobilizing. Thirty-five miles northwest of Grants Pass, OR. Timber and brush. Active fire behavior with uphill runs, group torching and backing. Evacuations in effect.

**Perry**, North Cascades NP, NPS. Sixteen miles northeast of Newhalem, WA. Timber. No new information.

**Snow Peak**, Colville NF, USFS. Nineteen miles west of Kettle Falls, WA. Timber, closed timber litter and brush. No new information.

**Cedar**, Shasta Trinity NF, USFS. CIMT (CA Team 2). CIMT is also managing the Swift Complex. Ten miles southwest of Hayfork, CA. Timber, chaparral and grass. Minimal fire behavior with creeping and smoldering. Numerous structures and energy infrastructure threatened. Evacuations in effect.

**Swift Complex**, Shasta Trinity NF, USFS. Nine miles southwest of Trinity Center, CA. Timber and brush. Moderate fire behavior with backing, flanking and creeping. Area, road and trail closures in effect.

**Blue**, Klamath NF, USFS. CIMT (CA Team 1). CIMT is also managing the Dillon and Log incidents. Ten miles east of Happy Camp, CA. Timber. Active fire behavior with flanking, group torching and short-range spotting. Numerous structures and infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Dillon**, Six Rivers NF, USFS. Sixteen miles north of Orleans, CA. Timber. Active fire behavior with uphill runs, flanking and short-range spotting. Numerous residences threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Log**, Klamath NF, USFS. Eighteen miles west of Etna, CA. Timber and brush. Active fire behavior with backing, flanking and creeping. Area closure in effect.

**Root**, Shasta Trinity NF, USFS. Six miles southwest of Dunsmuir, CA. Timber. Moderate fire behavior with single tree torching and creeping. Residences threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

**R-14 Buffalo**, Northern California District, BLM. Eighteen miles west of Gerlach, NV. Grass, brush and timber. Minimal fire behavior. Structures threatened.

**Pickett**, Sonoma-Lake Napa Unit, Cal Fire. One mile northeast of Calistoga, CA. Timber, grass and brush. Minimal fire behavior. Numerous residences and energy infrastructure threatened. Evacuations and trail closures in effect. Last report unless significant activity occurs.

Fifteen miles northeast of Drummond, MT. Grass, timber and heavy slash. Active fire behavior with short crown runs, torching and spotting. Numerous residences and communication infrastructure threatened. Area and road closures in effect.

**Ransome**, Kootenai NF, USFS. Eleven miles northwest of Libby, MT. Timber and brush. Active fire behavior with uphill runs and flanking. Residences threatened. Road closures in effect.

**Cloudrest**, Beaverhead-Deerlodge NF, USFS. CIMT (NW Team 8). CIMT is also managing the Bivens Creek incident. Fifteen miles northwest of Virginia City, MT. Timber. Minimal fire behavior with creeping, spotting and smoldering. Structures threatened. Area, road and trail closures in effect.

**Bivens Creek**, Beaverhead-Deerlodge NF, USFS. Fifteen miles north of Virginia City, MT. Timber. Minimal fire behavior with creeping, spotting and smoldering. Area, road and trail closures in effect.

**Island Creek**, Nez Perce-Clearwater NF, USFS. CIMT (NR Team 2). CIMT is also managing the East and Mire incidents. Fourteen miles east of Elk City, ID. Brush, closed timber litter and timber. Moderate fire behavior with flanking, torching and smoldering. Structures threatened. Road closures in effect.

**East**, Nez Perce-Clearwater NF, USFS. Forty-five miles southwest of Missoula, MT. Timber, brush and closed timber litter. Active fire behavior with flanking, group torching and long-range spotting. Road closures in effect.

**Mire**, Nez Perce-Clearwater NF, USFS. Thirty-five miles northeast of Lowell, ID. Timber, brush and closed timber litter. Active fire behavior with flanking, group torching and long-range spotting. Structures threatened. Road closures in effect.

**Knowles**, Northwestern Land Office, Montana DNR. Started on private land 11 miles southeast of Plains, MT. Timber and grass. Moderate fire behavior with isolated torching, backing and smoldering. Numerous structures threatened. Evacuations and area closures in effect. Reduction in acreage due to more accurate mapping.

**Sandbar 2**, Helena-Lewis and Clark NF, USFS. Thirteen miles northeast of Lincoln, MT. Closed timber litter and medium slash. Minimal fire behavior. Area and trail closures in effect. Last report unless significant activity occurs.

**Ulm Creek**, Idaho Panhandle NF, USFS. Thirty-eight miles southeast of Sandpoint, ID. Heavy slash, timber and brush. Active fire behavior with uphill runs, flanking and backing. Area, road and trail closures in effect.

\* **White Pine**, Nez Perce-Clearwater NF, USFS. Forty-four miles north of Lewiston, ID. Timber and brush. Moderate fire behavior with backing, torching and spotting. Area, road and trail closures in effect.

## **Predictive Services Discussion:**

Isolated mixed wet and dry thunderstorms are possible across the Washington Cascades into northeast Washington and the southern half of Idaho, but smoke may limit development in some areas. Isolated storms are likely to continue overnight near and west of the Cascades. Isolated to scattered mainly wet thunderstorms are expected to develop from southern Oregon and the eastern Sierra into the central and southern Great Basin, Southwest, and West Slope. The heaviest rain is likely in southern Arizona and southwest New Mexico where abundant moisture from decaying Hurricane Lorena is expected. Cooler temperatures are expected in California with seasonably low relative humidity in the teens and light winds overall except for gusty west winds along the east slopes of the Coast Ranges.

In the Eastern US, breezy and cool northwesterly winds will persist on the northern and central Plains to the Midwest. Dry conditions will persist in much of Texas, with south to southwesterly winds 12–20 mph, creating localized elevated conditions. A cold front will bring scattered showers and thunderstorms to Oklahoma and Kansas east into the Ohio and Tennessee Valleys. Isolated showers and thunderstorms will develop in the Northeast, with scattered thunderstorms in Florida, but dry conditions continue in the rest of the Southeast.
