Active fire behavior with group torching, flanking and short-range spotting. Numerous residences threatened. Evacuations and road closures in effect.

Katy Creek, Colville NF, USFS. Six miles northwest of Kettle Falls, WA. Timber and brush. Active fire behavior with flanking, backing and spotting. Structures threatened. Area and road closures in effect.

Rattlesnake, Colville Agency, BIA. CIMT (NW Team 7). CIMT is also managing the Lynx Mountain incident. Two miles west of Seven Bays, WA. Timber, brush and grass. Active fire behavior with wind-driven runs, torching and spotting. Residences and communication infrastructure threatened. Evacuations and road closures in effect.

Lynx Mountain, Colville Agency, BIA. Twenty-nine miles west of Chewelah, WA. Grass, brush and timber. Active fire behavior with wind-driven runs, torching and spotting. Numerous residences threatened. Evacuations and road closures in effect.

Lower Sugarloaf, Okanogan-Wenatchee NF, USFS. CIMT (NW Team 3). CIMT is also managing the Labor Mountain incident. Seventeen miles northwest of Entiat, WA. Timber and brush. Active fire behavior with backing, flanking and isolated torching. Numerous residences and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Labor Mountain, Okanogan-Wenatchee NF, USFS. Ten miles north of Cle Elum, WA. Timber and brush. Active fire behavior with backing, flanking and group torching. Structures threatened. Area, road and trail closures in effect.

Wildcat, Okanogan-Wenatchee NF, USFS. CIMT (NW Team 10). Thirty miles west of Naches, WA. Timber, brush and closed timber litter. Moderate fire behavior with flanking, creeping and torching. Numerous structures threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Emigrant, Willamette NF, USFS. CIMT (NW Team 13). CIMT (CA Team 3) mobilizing. Twenty-two miles southeast of Oakridge, OR. Medium slash, timber and closed timber litter. Active fire behavior with torching, flanking and uphill runs. Energy infrastructure threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Mark's Creek, Ochoco NF, USFS. CIMT (ODF Team 2). Eighteen miles east of Prineville, OR. Timber. Moderate fire behavior with backing, creeping and spotting. Residences and energy infrastructure threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Moon Complex (3 fires), Rogue River-Siskiyou NF, USFS. CIMT (GB Team 5). Thirty-five miles northwest of Grants Pass, OR. Timber and brush. Active fire behavior with group torching, flanking and backing. Residences threatened. Evacuations in effect.

Bridge, Malheur NF, USFS. CIMT (CA Team 4). Thirty-nine miles southwest of Baker City, OR. Timber and medium slash. Active fire behavior with backing, flanking and isolated torching. Residences and infrastructure threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Tacoma Creek, Northeast Region, Washington DNR. CIMT (GB Team 7). Started on private land 19 miles east of Colville, WA. Timber, brush and light slash. Moderate fire behavior with single tree torching, backing and flanking. Structures threatened. Road closures in effect.

Black Rock, Prineville District, BLM. Forty miles northeast of Madras, OR. Brush, timber and grass. Active fire behavior with wind-driven runs, short-range spotting and uphill runs. Residences threatened. Evacuations in effect.

Predictive Services Discussion:

Above normal temperatures will persist from the Pacific Northwest across the Northern Rockies with lower humidity east of the Divide, but temperatures and visibility will continue to be impacted by the smoke produced by the fires. Widely scattered mixed wet/dry thunderstorms will develop from the Northwest, across Idaho into Montana and Wyoming near and west of the Divide, with ignitions possible, although humidity will be increasing. Isolated storms are likely to continue overnight in parts of northern Washington, northern Idaho and western Wyoming and outflows from these storms have the potential to affect the ongoing fires. Breezy southwest winds 15–20 mph with gusts to 35 mph amid humidity as low as 8–15% will develop from the southern Sierra, north across Nevada, southeast Oregon and southwest Idaho creating locally elevated conditions. Widely scattered wet thunderstorms are expected in the eastern Great Basin, Colorado and New Mexico, with thunderstorms pushing east from the Central Plains to the Texas Panhandle.

In the Eastern US, scattered showers in the Northeast and Mid-Atlantic will move east offshore later in the day, followed by cooler and drier air and northwest winds. Showers and thunderstorms will continue in the Coastal Southeast, Florida and southern Texas with warming temperatures in the Plains.
