#### **Predictive Services Discussion:**

Above normal temperatures will persist from eastern Washington and Oregon across Idaho and the Northern and Central Rockies, although temperatures will be impacted in some areas due to smoke and increasing clouds. Early morning showers and thunderstorms may be ongoing in northern Washington and Montana along the Divide. Showers and thunderstorms will move into northwest California and western Oregon ahead of an incoming Pacific trough in the morning and increase north and east across northern California, central and western Oregon and parts of Washington through the afternoon and evening along with a significant decrease in temperatures and increases in humidity. Wetting rains are most likely in northwest California and western Oregon. Drier conditions are expected across much of the Northern Rockies, Great Basin, Central Rockies and the Southwest with humidity 15–20%, except for lower humidity 8–12% from the Southern California Mountains and deserts north across Nevada, western Utah and into southeast Oregon and southwest Idaho with breezy southwest winds 15–20 mph with gusts to 35 mph creating locally elevated conditions. Lingering moisture will allow for isolated thunderstorms in the Northern and Central Rockies and parts of Utah. Morning thunderstorms are possible in eastern Nebraska, Kansas and northern Oklahoma with storms developing later in the day from the Texas Panhandle north across the Central and Northern Plains to the Upper Midwest with warming temperatures.

In the Eastern US, scattered showers and thunderstorms will continue in Florida, along parts of the Gulf Coast and over far southern Texas with cooler and drier air across the rest of the East, with humidity 25–40%.
