Predictive Services Discussion:

A Pacific low will move onshore Northern California and southwest Oregon on Tuesday. Temperatures will drop along with increasing relative humidity across much of the Pacific Northwest, Northern California, northern and western Great Basin, northern Idaho, and western Montana. Scattered showers and thunderstorms in the morning over parts of Washington, western Oregon, and northwest California will spread northeast into central Oregon, the Washington Cascades and northwest Nevada, lingering overnight. Widely scattered mixed wet and dry thunderstorms are expected to increase along and west of the Divide from Idaho and Montana south across Wyoming, Colorado and New Mexico. Drier conditions and strong winds are expected across the southern and eastern half of the Great Basin into northern Arizona and the Southern California mountains and deserts in the afternoon and evening creating locally elevated conditions. However, many of these areas in the Great Basin and Arizona have seen precipitation in the last week.

In the Plains, early morning showers and thunderstorms are expected over eastern Kansas and Nebraska northeast to the Upper Midwest and western Great Lakes, continuing through the day. Above normal temperatures will continue along and east of the Divide into the Plains. In the Eastern US, scattered showers and thunderstorms will continue in Florida and along the Gulf and East Coasts and will move into parts of Coastal New England by the evening. Cool and dry air will continue across the rest of the East.

Clouds and showers with isolated thunderstorms will begin increasing in Hawai'i ahead of weakening Kiko along with increased surf.
