#### **Predictive Services Discussion:**

The very slow-moving Pacific low will drift east into the western Great Basin and eastern Oregon on Thursday. Cooler temperatures and higher RH will continue across northern and central California, the Pacific Northwest, western Great Basin, and northern Rockies, with minimum RH 30-40% or higher. However, a pocket of drier air with RH 25-30% will continue in eastern Washington. Isolated early morning thunderstorms becoming more widespread in the afternoon with areas of wetting rain are expected in many of the same areas as Wednesday, across the northern Intermountain West, central Rockies, and Southwest. Precipitation will remain convective with many areas expecting rainfall 0.05-0.15", and areas of heavier rainfall over 0.25". Showers and thunderstorms will likely continue overnight from eastern Washington and Oregon across the northern and central Rockies with thunderstorms pushing east into the northern Plains in the evening and continuing overnight. Low RH and strong winds will push east across the Southwest, eastern Great Basin, and central Rockies with southwest wind gusts 30-40 mph amid minimum RH 12-15% creating locally elevated conditions. Many of these areas have seen precipitation in the last two weeks that will mitigate concerns, but initial attack is possible.

Well above normal temperatures will stretch from the Plains to the Mid-Atlantic, with temperatures briefly increasing closer to normal in the Northeast. Scattered showers and thunderstorms will continue in central and southern Florida, with drier air across the rest of the East as RH falls to 25-35%.
