Predictive Services Discussion:

A high-pressure ridge quickly amplifies along the West Coast. Light to moderate northeast to east winds 10-15 mph developing from western Washington and Oregon to Northern California, increasing Monday night with 25-35 mph along the ridges. Temperatures will warm 5-10 degrees today across the Northwest and California, with RH dropping to 15-25%. Overnight recovery will be poor to moderate with RH 25-35% in the drier locations, especially along and west of the Cascades into California and the Great Basin. Fire behavior will pick up on existing fires with an increase in initial attack possible from recent lightning. Low pressure will weaken as it tracks east across the northern Great Basin and northern Rockies. Cooler temperatures, higher RH and scattered showers and thunderstorms will occur across the northern Rockies, northern Great Basin and northern Colorado into the Plains.

Strong high pressure from the Great Lakes to the lower Mississippi Valley with continued well above normal temperatures and RH of 25-35% across much of the East, except for isolated thunderstorms with small rainfall footprints from the southern Plains to the Tennessee Valley. Low pressure in the Coastal Mid-Atlantic will generate scattered showers and cooler temperatures. Isolated showers and thunderstorms continue in Florida.
