**Lower Sugarloaf**, Okanogan-Wenatchee NF, USFS. Transfer of command from CIMT (NW Team 3) to CIMT (NW Team 2) will occur today. CIMT is also managing the Labor Mountain incident. Twelve miles northeast of Leavenworth, WA. Timber and brush. Active fire behavior with backing, flanking and single tree torching. Numerous structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Labor Mountain**, Okanogan-Wenatchee NF, USFS. Ten miles north of Cle Elum, WA. Timber and brush. Active fire behavior with backing, flanking and torching. Structures threatened. Area, road and trail closures in effect.

**Moon Complex** (2 fires), Rogue River-Siskiyou NF, USFS. Transfer of command from CIMT (GB Team 5) to CIMT (NW Team 13) will occur tomorrow. Thirty-five miles northwest of Grants Pass, OR. Timber, closed timber litter and brush. Minimal fire behavior with backing, creeping and smoldering. Structures threatened. Area, road and trail closures in effect.

**Lynx Mountain**, Colville Agency, BIA. Transfer of command from CIMT (NW Team 7) to CIMT (SA Team 3) will occur today. CIMT is also managing the Rattlesnake incident. Seven miles northwest of Inchelium, WA. Medium slash, brush and timber. Active fire behavior with flanking, backing and torching. Numerous residences threatened. Evacuations and road closures in effect.

**Rattlesnake**, Colville Agency, BIA. Two miles west of Seven Bays, WA. Timber, brush and grass. Minimal fire behavior with creeping and smoldering. Residences and communication infrastructure threatened. Evacuations and road closures in effect.

**Crown Creek**, Northeast Region, Washington DNR. CIMT (NR Team 6). CIMT is also managing the Katy Creek incident. One mile southeast of Marble, WA. Timber and brush. Minimal fire behavior with creeping and smoldering. Numerous residences threatened. Evacuations and road closures in effect.

**Katy Creek**, Colville NF, USFS. Six miles northwest of Kettle Falls, WA. Timber and brush. Active fire behavior with torching, group torching and short-range spotting. Structures threatened. Evacuations, area, road and trail closures in effect.

**Emigrant**, Willamette NF, USFS. Transfer of command from CIMT (CA Team 3) to CIMT (RM Team 1) will occur today. Twenty-four miles southeast of Oakridge, OR. Medium slash, timber and closed timber litter. Minimal fire behavior with creeping and smoldering. Energy infrastructure threatened. Area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

**Kelsey Peak**, Medford District, BLM. CIMT (ODF Team 1). Fourteen miles west of Glendale, OR. Timber, brush and closed timber litter. Minimal fire behavior with creeping and smoldering. Road and trail closures in effect

**Tacoma Creek**, Northeast Region, Washington DNR. CIMT (GB Team 7). Started on private land 15 miles northwest of Cusick, WA. Timber, light slash and brush. Minimal fire behavior with backing and creeping. Communication and energy infrastructure threatened. Road closures in effect.

**Wildcat**, Okanogan-Wenatchee NF, USFS. Thirty miles west of Naches, WA. Timber, brush and closed timber litter. Moderate fire behavior with flanking, creeping and torching. Numerous structures threatened. Area, road and trail closures in effect.

**Foley Ridge**, Willamette NF, USFS. Thirty-five miles west of Bend, OR. Timber and closed timber litter. Moderate fire behavior with creeping, isolated torching and smoldering. Structures and communication infrastructure threatened. Area, road and trail closures in effect.

**Tunnel Creek**, Olympic NF, USFS. Ten miles southwest of Quilcene, WA. Timber. Active fire behavior with group torching, flanking and backing. Trail closures in effect.

#### **Predictive Services Discussion:**

Tropical moisture pushes farther north into central and southern California, Arizona, and southern Nevada for increasing RH, cooler temperatures, breezy winds, and scattered showers and thunderstorms. Isolated drier lightning possible on the northern periphery of the moisture in northern California and western Nevada. Areas of wetting rain are expected across the southern half of California, with localized amounts 0.25-0.50". Above normal temperatures and dry conditions across the rest of the West and Rockies. Fire behavior will pick up on existing fires with an increase in initial attack possible from recent and current lightning. Breezy west winds along and west of the Cascades with higher relative humidity.

Cool temperatures, and widespread showers and thunderstorms, continue in the Plains, south to northern Texas and New Mexico with localized severe weather. A cold front will move south from Canada across the Great Lakes with cooler temperatures and breezy north winds. High pressure moves across much of the East into the southern Plains with continued above normal temperatures and RH 25-35%. Isolated thunderstorms possible in the Lower Mississippi Valley and Southeast with an increase in initial attack. Scattered showers and thunderstorms continue in central and southern Florida.
