Subject: 2026 Joint FS/DOI Procurement Surge Model

Background

In 2025, limited government purchase card and warranted contracting capacity required a revised procurement support model for wildfire and all-hazard incidents.

The interagency surge structure implemented in 2025 proved effective and scalable. Based on after-action feedback and joint coordination between the U.S. Forest Service's At Incident Management Support (AIMS) and Department of Interior's Remote Incident Support (IRIS), procurement support is further aligned and strengthened for 2026.

In 2026, the Buying Team (BUYT) model will transition to the Expanded Procurement Support Organization (EPSO). Under EPSO, procurement support is provided through the coordinated USFS AIMS and DOI IRIS surge structures. Support is configured to meet the incident's needs and may include micro-purchase support, warranted contracting support, or both. Support may be provided remotely or on-site depending on resource availability.

All fires will be supported under this aligned interagency model across DOI, USFS, and state coordination.

2026 Interagency Procurement Support Model

Local Micro-Purchase Capability

Local units that have micro-purchase capability may continue to order and manage micro-purchases locally for small or emerging incidents. Local capacity remains encouraged and supported.

Expanded Procurement Support Organization (EPSO)

For larger, complex, or sustained incidents procurement support will be provided through the coordinated USFS AIMS and DOI IRIS surge model.

Micro-Purchase Surge Support

- Coordinated under the AIMS/IRIS surge structure (EPSO)
- Resources will be assigned in IROC at NICC

Warranted/Contracting Support

Warranted actions (EERAs, LUAs, ICAs, and other agreements) under EPSO continue to remain assigned by jurisdictional/protection agency:

- USFS: AIMS Surge
- DOI (BIA, BLM, FWS, NPS): IRIS Surge
- State incidents: Follow state procurement procedures or EPSO model

2026 Ordering Process

The following outlines how to utilize EPSO:

- Requesting party submits the [Joint Agency Surge Ordering Form](#).
- The form routes to USFS AIMS or DOI IRIS based on jurisdiction.
- Surge personnel are identified and coordinated by AIMS/IRIS.
- Resources will be assigned in IROC at NICC.

This process establishes one coordinated entry point, clear accountability, and national workload visibility.

Tracking and Transparency

USFS AIMS and DOI IRIS host:

- Micro purchases and warranted procurement actions are tracked through FireNet and maintain incident FireNet files formerly managed by BUYTs.
- Provide real-time tracking of requests, assignments, and closeout status.
- Maintain visibility for incident leadership, finance, and coordination centers.

Interagency Alignment

USFS AIMS and DOI IRIS will create a coordinated surge structure that:

- Replaces fragmented legacy buying team structures.
- Integrates micro and warranted support under EPSO.
- Ensures compliance and procurement standards.
- Provides scalable, measurable surge capability.

Workforce Participation

Individuals who previously served as Buying Team Leaders (BUYL) or Buying Team Members (BUYM) are strongly encouraged to [apply](#) to the joint AIMS/IRIS (EPSO) application process. EPSO applicants will only be considered for assignments.

2026 EPSO Model Review

- Preserves local micro capability.
- Replaces legacy buying team ordering with a coordinated surge process.
- Integrates micro and warranted support.
- Aligns USFS and DOI processes.
- Enhances transparency through FireNet-hosted trackers.
- Provides measurable national surge capacity.
