IMSR Update (Sean Peterson)

PL1, 761 new fires, 13 uncontained large fires, 8 crews, 118 engines, 5 helicopters, 700 personnel assigned.

Northern Rockies: PL1, activity in ND,

Southern Area: PL2, 374 new fires, 12 uncontained large fires.

Bee Rock Creek – NC state, moderate behavior, hardwood litter, structures threatened, evacuations, 400 acres, 0% contained.

HAOE Lead – NC, active behavior, hardwood litter, 800 acres, 0% contained.

Powerline – FL FS, active behavior, timber, 200 acres, 5% contained.

Hilliardville – Moderate behavior, southern rough and timber, 1,300 acres, 60% contained.

Juniper Swamp – FL, moderate behavior, timber and southern rough, 705 acres, 60% contained.

Buck Creek – Active behavior, hardwood litter, 550 acres, 40% contained.

Rocky Mountain: PL1, 1 uncontained large fire.

Buffalo – Minimal behavior, light fuels, 611 acres, 80% contained.

Eastern Area: PL2, moderate to heavy IA in MN.

Dugdale – 3,744 acres, 100% contained.

Partridge Two – MN, structures threatened, 800 acres.

Predictive Services Update

Weather Summary (Jim Wallmann)

WEATHER SUMMARY

Short-term (through Friday)

- Breezy northwesterly winds with elevated conditions for portions of the central/northern Plains today
- Isolated mixed wet/dry thunderstorms for the Southwest and Greater Four Corners tomorrow
- Breezy/dry southwest winds for eastern Arizona, New Mexico, and the adjacent High Plains Wednesday and Thursday, peaking Thursday with widespread elevated to critical conditions and moderate to high-risk significant fire potential
- A mainly dry cold front will move through the Appalachians and East Coast today, with breezy/dry northwesterly winds bringing areas of elevated conditions for the east slopes of the Appalachians to the coast
- Strong downslope winds at times for the central/eastern Interior of Alaska late this week

Long-term (Saturday through next Wednesday)

- Scattered showers for the Southwest and Four Corners this weekend before warm/dry and potentially breezy weather returns next week
- Widespread rain for the southern Plains, Mid-Mississippi/Ohio Valleys this weekend, with severe thunderstorms likely as well
- Drier east of the Appalachians and Florida, but minimum RH is likely to increase and remain above 30% limiting fire potential where green-up is slower to occur
- Periods of light to moderate precipitation for the northern half of the West



Fuels Summary (Steve Larrabee)

ERC percentiles still showing uncertainty.

FL will continue to see elevated fire potential and fire danger.

SW at 90th percentile or higher for ERCs, well ahead of schedule.

NE discussing moderate fire danger levels.

Olympic Peninsula is seeing ERCs in the 90th percentile.

Drought in Mexico has been expanding rapidly, in addition to parts of Canada.

Admin Topics

Liaison Expectations and Changes in Report Out Duties and Resource Allocation

NMAC will have an NMAC Operations Coordinator and NMAC Logistics Coordinator.

Functional area liaisons will provide resource allocation report outs to the Operations Coordinator.

Liaisons will not report out in NMAC, will request agenda time as needed for additional discussion topics.

NMAC Logistics Coordinator will primarily be one of the CODs.

NMAC Operations Coordinator will be Deputy Assistant Manager or COD.

Report outs must be to the NMAC Coordinators by 0900.

Incident Status Summary Update

Existing memo from 2017 considers alternatives for gauging incident completion utilizing a weighted matrix.

Concern with SIT 209 application as well as updating the 209 form.

Recommend SME group review and update 2017 memo for redistribution.

Consider contained vs completed language and the differences between agencies.

Clarify where completion fires fall in the line of priorities.

Measuring success by percent of objectives complete could be difficult to understand.

Put together 2025 recommendation for May 1.

AIMS Surge Incident Purchasing Memo

Reduced capacity across many agencies with do not purchase lists being distributed.

BUYT are generally interagency, reduce agency-specific language.

Engage NWCG Incident Business.

Memo will be added to the SharePoint for review and edits.

NMAC Fatigue Memo

Traditional fatigue management mitigation focuses on post-assignment.

Request NMAC work with chartered bodies to encourage CIMTs to establish incident sleeping areas that provide the highest sleep quality, request CIMTs summarize best practices, compile practices and identify policy updates, and develop trigger points for sending personnel to hotels.

Minimize prolonged poor sleep conditions to mitigate fatigue.

Encourage CIMTs to support distributed operations with best practices allowing crew leaders to make decisions for their crews' best practice.

IWDG has compiled data on cost and health benefits of incident camp vs hotels.

ICAC has no oversight of the teams and may not be the appropriate group to task.

Consider a more doctrinal, less scripted approach.

Consider barriers for building additional best practices.

Consider Agency Admin subgroup as the lead group.

Recommend reviewing memo language, sending comments to Eric.

National PS

NICC BLM Meteorologist vacancy working on updating PD to better align with PSOG long term plan which may increase grade. Meteorologist group discussing the ability to share meteorologists between GACCs where needed.

Several NWS meteorologists available to assist NICC and potentially remote-support other areas.

Will work to prioritize current products.

IMET availability concerns linked to office staffing shortages.

Potential process for meteorologist support from DoD?
