## IMSR Update (Sean Peterson)

PL1, light IA, 857 new starts, 11 uncontained large fires, 16 crews, 108 engines, 11 helicopters, 960 personnel committed.

**Northern Rockies:** PL1, several large grass fires in ND.

**Southern Area:** PL2, improving conditions, 312 new fires, 5 uncontained large fires.

HAOE Lead – Minimal behavior, litter and slash, 3,100 acres, 57% contained.

Bee Rock Creek – NC State, minimal behavior, litter and timber, 2,100 acres, 94% contained.

Whoopflarea – Minimal behavior litter, 117 acres, 50% contained.

Curry Island – Active behavior, grass, 1,000 acres, 90% contained.

Juniper Swamp – FL, moderate behavior, timber, 2,500 acres, 68% contained.

**Rocky Mountain:** PL1, light IA, 1 uncontained large fire.

Plum Creek – NE state, grass, active behavior, structures threatened, 24,000 acres, 0% contained.

**Eastern Area:** PL2, moderate IA, 460 new starts, 5 uncontained large fires.

Jones Road – NJ FS, active behavior, timber, torching and spotting, 13,500 acres, 50% contained.

Danny's – Moderate behavior, hardwood litter, 1,250 acres, 50% contained.

Packerton – PA state, minimal behavior, litter, 560 acres, 66% contained.

St. Joe – MN DNR, active behavior, slash, 340 acres, 95% contained.

4 Square Mile – MN, minimal behavior, light fuels, 422 acres, 95% contained.

## Predictive Services Update

### Weather Summary (Jim Wallmann)

#### WEATHER SUMMARY

##### Short-term (through Friday)

- Breezy/dry southwest winds across the southern Appalachians today before scattered showers and thunderstorms are expected Tuesday into Thursday spreading to the Carolina coast, where high-risk significant fire potential is forecast Wednesday due to the lightning
- Florida will remain dry this week with moderate significant fire potential, although winds will be light away from sea breezes
- Warm and dry in the Greater Four Corners, with localized elevated conditions for the West Slope today and more elevated conditions possible Friday due to increased southwesterly winds
- Light precipitation for the northern Plains and Upper Midwest today, but breezy/dry conditions may return late this week

##### Long-term (Saturday through next Wednesday)

- Breezy/dry southwest winds to continue across the Greater Four Corners Saturday, followed by a chance of precipitation Sunday, while light to moderate precipitation occurs across the northern half of the West
- Continued dry in Florida, with low minimum RH below 30% possible this weekend, although winds are still expected to remain light outside of sea breezes
- Wet across much of the Plains this weekend into early next week, with rain likely across the Dakotas and Minnesota, as well, but not all areas will receive wetting rain



### Fuels Summary (Steve Larrabee)

FL remains an area of concern; rainy season may be delayed up to a month.

Portions of the EA are up to 4 weeks away from effective green-up.

ERCs in the SW are sitting at 90<sup>th</sup> percentile.

Columbia Plateau are starting to see large fires emerge.

### International Spring Working Meeting Update

Updated Operating Plans between Canada, Australia, and US.  
Crosswalk document is nearly finalized for NMAC review.  
Continued concern with medical payments and insurance for US personnel deployed to Canada.  
Finalized billing flat rate for mobilization between US and Australia.  
Discussed tour of duty and expected shift durations.  
Formalized successional planning and trainee/mentee positions.  
Anticipating active fire season in western Canada.  
Australia has seen simultaneous flooding and fire activity through the season.  
CIFFC and Australia may both be able to mobilize resources to US in 2025 if needed.

### IWDG Updated Charter

Recommend leaving the mission as is, update specific bullet point actions.  
Update membership, review and clarify short term vs long term liaison roles.  
Provide feedback to Jesse by Tuesday, April 29.  
Review draft Charter May 1.

### NMAC Fatigue Memo

Consider which group should be tasked and include AAs.  
Remove bullet point for developing trigger points for establishing alternate sleeping arrangements.  
Concern with the ability to utilize federal credit cards for booking hotels.  
Revisit Thursday, May 1.

### AIMS Surge Incident Purchasing Memo

Clearly manage expectations on items that can be provided for 2025 fire season.  
Concern with lack of interagency communication regarding purchasing.  
Generalize NMAC memo due to upcoming changes expected with DOI procurement centralization.  
Reinforce contracts that will maintain availability.  
EERAs and land-use agreements may be difficult to put in place.  
Discuss with DOI Incident Business, agency leadership and GAs.  
Revisit Thursday, May 1.

### CIMT Request Form Fatal Flaw Revie

Will consider when and how rationales are discussed consistently.  
Consider criteria for CIMT request form.  
Jesse will send to CGAC for review and discussion on Wednesday, April 30.
