IMSR Update (Sean Peterson)

PL2, light IA, 446 new fires, 8 uncontained large fires, 3 CIMTs, 27 crews, 74 engines, 15 helicopters, 1,500 personnel assigned.

South Ops: PL2, moderate IA, 32 new starts, 1 uncontained large fire.

Democrat – 100% contained.

Jaw – Minimal behavior, light fuels and timber, 4,100 acres, 60% contained.

Southern Area: PL1, light IA, dry conditions continue in FL.

Green Gate – FL state, active behavior, southern rough, 350 acres, 75% contained.

Eastern Area: PL3, light IA, 2 uncontained large fires, 1 CIMT.

Camp House – EA Team 1, MN DNR, minimal behavior, timber, structures threatened, evacuations, 12,100 acres, 73% contained.

Jenkins Creek – Minimal behavior, timber, residences threatened, evacuations, 16,750 acres, 13% contained.

Southwest: PL3, light IA, 4 uncontained large fires, 2 CIMTs.

Cody – SW Team 4 mobilizing, extreme behavior, light fuels, structures threatened, 1,000 acres, 0% contained.

Broadway – Active behavior, chaparral, structures threatened, 800 acres, 0% contained.

Greer – SW Team 3 TOC local unit tomorrow, minimal behavior, light fuels, 20,800 acres, 88% contained.

Blind – Minimal behavior, timber and grass, 6,300 acres, 90% contained.

Weather Summary (Jim Wallmann)

WEATHER SUMMARY

Short-term (through Monday)

- Breezy southwest winds and very low RH for the southern Great Basin, West Slope, and Southwest through Saturday, with critical conditions and new significant fires most likely in the Southwest where fuels are driest
- Continued dry in the Upper Midwest, with locally breezy northerly winds today, but winds overall are likely to remain light
- Showers in the northern half of the West today followed by increasing temperatures for the holiday weekend
- Dry in Florida except for scattered wet thunderstorms in South Florida through tomorrow, with fire
 potential to decrease in South Texas over the weekend due to increasing moisture and thunderstorms
- Mild and dry for Alaska through Saturday, with isolated thunderstorms over the Interior late Sunday into Monday

Long-term (Tuesday through next Saturday)

- · Continued dry in the Midwest with elevated background potential and possible winds late next week
- · Above normal temperatures are expected in the West, but areas of precipitation are more uncertain
- The favored idea will bring warmer temperatures to the northern half of the West, but wetter conditions to New Mexico, with mixed wet/dry thunderstorms in eastern Arizona
- Wetter conditions mid-next week for the southern Plains, Florida, and southeast Atlantic coast reducing potential



Fuels Summary (Steve Larrabee)

Fuels and Fire Behavior Advisory active for White Mountains/Gila Region South-Central NM Mountains.

CA at lower elevations beginning to cure, seeing increase in grass fires.

Annuals starting to cure in Snake River and Columbia basins.

Elevated ERCs continue in FL.

Conditions will continue to be dry in SW, trending back up to the 90th percentile for ERCs.
