#### **Intel Resource Dashboard**

NIFC Agol account required for access.

Recommend creating a stacked bar chart for helicopter and crew types.

RX only includes in "Resources Assigned Nationally" table.

#### **Crew Allocation Procedures**

NMAC Operations will receive leader's intent for where crews should be allocated or be directed to work within the parameters.

Chart will include historical crew allocation data as well as current allocation percentages and upcoming crew cliffs.

Crew allocation percentages could fall outside historical norms based on current conditions.

Recommend allowing Crew Coordinator and NICC make crew allocations.
