IMSR Update (Sean Peterson)

PL2, 759 new fires, 11 uncontained large fires, 1 CIMT committed, 1 NIMO team, 44 crews, 134 engines, 29 helicopters, 2,400 personnel assigned.

Northwest: PL1, several extended attack fires in WA.

Butte Creek – Minimal behavior, light fuels, structures threatened, 1,775 acres, 40% contained.

South Ops: PL2, moderate IA, 19 new starts, 1 uncontained large fire.

Inn – BLM, brush and timber, minimal behavior, 730 acres, 82% contained.

Great Basin: PL1

Twin Butte – Active behavior, grass, 2,400 acres, 100% contained.

Southern Area: PL1, light IA, 2 uncontained large fires.

Wood – DoD, moderate behavior, timber, precipitation, no issues or concerns, 1,200 acres, 80% contained.

North Bear Bay Road – FL state, no issues or concerns.

Eastern Area: PL2, light IA, 3 uncontained large fires, 1 NIMO team.

Jenkins Creek – NIMO Team 1, managing Horse River, minimal behavior, brush and timber, 16,000 acres, 95% contained.

Horse River – Minimal behavior, brush and timber, precipitation yesterday, 12 acres, 0% contained.

Camp House – MN DNR, minimal behavior, brush and timber, structures lost, 12,000 acres, 98% contained.

Southwest: PL3, light IA, 3 uncontained large fires, 1 CIMT.

Cody – SW Team 4 TOC local unit tomorrow, light fuels, minimal behavior, 1,200 acres, 90% contained.

Paradise – NM, timber and grass, moderate behavior, residences threatened, 730 acres, 12% contained.

Camp – Light fuels, minimal behavior, light fuels, 875 acres, 75% contained.

Predictive Services Update

Weather Summary (Jim Wallmann)

WEATHER SUMMARY

Short-term (through Monday)

- Well above normal temperatures in the West through Saturday, with hot temperatures 15-25°F above normal Friday and Saturday and possible record highs for May
- Isolated mixed wet/dry thunderstorms in the Southwest through Saturday to increase initial attack with moderate significant fire potential
- Breezy/dry westerly winds in the Cascade Gaps into the Columbia Basin today and Saturday for moderate significant fire potential
- Relief for the Southwest, eastern Great Basin, and central Rockies Sunday into Monday due to widespread showers and thunderstorms bringing wetting rain
- Little precipitation for the northwestern US, however, with dry north winds possible in northern California
- Continued dry in the Upper Midwest with breezy northwest winds today and tomorrow and moderate significant fire potential

Long-term (Tuesday through next Saturday)

- Cooler next week in the West, but dry conditions will return by late next week with lowering RH
- Fire potential will be highest in northern California and Columbia Basin, while potential will remain low in the Greater Four Corners through next week due to the precipitation
- Relief due to widespread wetting rain for the Upper Midwest mid-next week before drier conditions return next weekend



Fuels Summary (Steve Larrabee)

Fuels and Fire Behavior Advisory issued 5/23 for Southeast Arizona.

Above 97th percentile for ERCs in portions of the Southwest.

Expected fire danger improvement in Great Lakes region.

Northwest will begin to see ERCs above normal with the high heat.

- Southwest: No big needs, touch and go fire held on Coronado with aircraft.

Greg Smith (NASF and Rocky Mountain)

- NASF: 2 airtankers from AK sent to Saskatchewan.
- Rocky Mountain: Minimal activity, no needs.

Chuck Russell (NPS and California)

- NPS:
- NOPs: Hot, dry weather, beginning to preposition resources. Will have night capable helicopter. Smokejumpers will be running dash 8 platform out of Redding.
- SOPs: Releasing resources from Inn incident.

Josh Simmons (BIA and Northwest)

- BIA: Assessing DRP personnel.
- NW: 77 fires for over 2,600 acres, anticipating increase in activity, 6 IHCs available. WA DNR brought on two contract EU LATs, T2 rappel ship on June 1.

Admin Topics

Interagency Procurement Memorandum

Warranted work will be separated by state, DOI, and FS.

Personal items, capped inventory, pre-orders, and items that can be purchased at the home unit will all be limited.

Will work through GACC BUYT Coordinators.

Self-sufficiency will be critical for the first 48 hours.

DOI work flow chart will be included with memo.

NMAC memo will include FS-specific flow information as well.

Concern with specific “Do not buy” list, some flexibility will be added for times when items are required.

Ensure teams are arriving to incident fully prepared.

Julie and Shane will modify the attachment.

DOI tracker will be live June 1.

Team site link will be added to the memo.

Local unit micro-purchasing teams capabilities will overlap with those of the DOI procurement team to ensure all incidents are covered.

2025 Initial Attack Surge Capacity
