IMSR Update (Kat Sorenson)

PL3, light IA, 174 new starts, 33 uncontained large fires, 7 CIMTs, 1 NIMO Team, 222 crews, 487 engines, 112 helicopters, 10,670 personnel assigned.

North Ops: PL3, 16 new starts, 2 uncontained large fires, 2 CIMTs.
Big Cliff – Incorporating into Orleans Complex, CA Team 4, 90 acres.

Northwest: PL3, 35 new starts, 8 uncontained large fires, 3 CIMTs, 1 NIMO Team.
Bear Gulch – Nimo Team, NW Team 7 mobilizing, active behavior, timber, evacuations, 1,989 acres, 3% contained.
Burdoin – NW Team 13 TOC local unit 8/3, minimal behavior, timber and grass, communities threatened, 10,675 acres, 79% contained.
Lost Tom – Active behavior, light fuels, residences threatened, 1,100 acres, 90% contained.

Great Basin: PL3, heavy IA, 32 new starts, 6 uncontained large fires, 1 CIMT.
Monroe Canyon – GB Team 5, extreme behavior, brush and timber, communities and infrastructure threatened, evacuations, 36,600 acres, 11% contained.
Mill – Active behavior, light fuels, structures and habitat threatened, 1,800 acres, 20% contained.
Moonshine – Extreme behavior, light fuels, habitat threatened, 2,800 acres, 30% contained.
East Horse – Active behavior, light fuels, habitat threatened, 411 acres, 50% contained.
Striker – BOD, active behavior, light fuels, 2,000 acres.

Rocky Mountain: PL3, 25 new starts, 5 uncontained large fires.
Turner Gulch – Moderate behavior, expecting CIMT order, brush and timber, residences threatened, 20,700 acres, 51% contained.
Veas – Minimal behavior, light fuels, structures threatened, 4,900 acres, 40% contained.

Alaska: PL2, 1 new fire.

Southwest: PL3, 27 new starts, 7 uncontained large fires, 1 CIMT.
Dragon Bravo – Grand Canyon NP, SW Team 2, extreme behavior, brush, structures and infrastructure threatened, evacuations, 105,000 acres, 9% contained.

Predictive Services Update

Weather Summary (Jim Wallmann)

WEATHER SUMMARY

Short-term (through Saturday)

- Isolated to scattered mixed wet/dry thunderstorms for the northwestern US with the peak in activity today
- A significant increase in initial attack is expected, with moderate to high-risk significant fire potential and several new large fires likely to emerge through Friday
- Very dry conditions continue for much of the Great Basin, Arizona, and central Rockies, with areas of breezy winds for eastern Nevada, Utah, the West Slope, and northern Arizona creating elevated conditions and high-risk significant fire potential into Saturday
- The monsoon remains weak, with thunderstorms mostly east of the Divide in Colorado/New Mexico with a threat of dry thunderstorms on the western fringe from the Mogollon Rim to the West Slope
- Interior Alaska will warm and dry into the weekend but significant fire potential will remain low

Long-term (Sunday through next Saturday)

- Periods of breezy winds and low RH are likely Sunday through Tuesday for the Great Basin, Arizona, and central Rockies amid very low RH and poor overnight recovery, with holdovers likely to emerge in places that observe lightning late this week
- The monsoon wanes with few thunderstorms Sunday/Monday, with a modest return in the form of isolated mixed wet/dry thunderstorms west of the Divide mid to late next week
- Moderating conditions due to cooler temperatures into mid-next week for the northern half of the West, with localized wetting rain from northeast California to western Montana
- Overall fire potential will remain high across the Great Basin and Greater Four Corners due to winds and potential lightning



Fuels Summary (Steve Larrabee)

Dryness continues across all of the west including HI.

Drought improved/resolved in parts of central US and FL.

Drought intensified/expanded in Greater Northwest, Intermountain West, and West Slope.

Dry conditions are returning to parts of Southeast.

Elevated ERCs up to 97th percentile in part of the Intermountain West.

New England has been fairly dry though no fire activity has been seen yet.

AK will see brief increase in fire potential but overall long-term trend looks good.

Northwest may see a short term improvement in fuels before drying out.

Lightning sleepers will be a concern across the west.

Brian Achziger (BLM and Great Basin) – Brad Sawyer

- BLM: NTR
- Great Basin: Monroe Canyon incident active on all sides, potential for ordering a second CIMT.

Shane McDonald (FWS, Alaska, and Southern Area) – Kevin Conn

- FWS: NTR
- Alaska: AFS looking to have all resources off incidents by early next week. Will send personnel to TX next week to retrieve engines for compact utilization.
- Southern Area: NTR

Aitor Bidaburu (USFA and Northern Rockies)

- USFA: NTR
- Northern Rockies: Prepared to support other GAs.

Russ Long (USFS, Eastern Area and Southwest)

- FS: Monitoring pay cap.
- Eastern Area: NTR
- Southwest: Dragon Bravo continues to be the main concern. Bracing for elevated conditions.

Greg Smith (NASF and Rocky Mountain)

- NASF: WA has been the most active state, substantial increase in IA.
- Rocky Mountain: Turner Gulch CIMT request submitted.

Chuck Russell (NPS and California)

- NPS: Monroe Canyon incident causing NP personnel to COOP with power outages.
- NOPs: Increased IA, expecting additional incidents with expected lightning, heavy utilization of SMKJ. Orleans Complex in need of crews.
- SOPs: Expecting additional IA.

Josh Simmons (BIA and Northwest) – Shane Santos

- BIA: NTR
- NW: Geyser Canyon incident 500 acres up to 50% contained. Rock Creek incident grew over 900 acres in light fuels, T3 IMT assigned. Two surge packages assigned to WA.
