Predictive Services Update

Weather Summary (Jim Wallmann)

WEATHER SUMMARY

Short-term (through Sunday)

- High-risk significant fire potential today for the northeast Great Basin and southwest Montana due to mixed wet/dry
 lightning and breezy southwest winds continuing the escalation in activity that began Wednesday, with thunderstorm
 risk continuing for southwest Montana and Yellowstone National Park tomorrow
- Gradually cooler conditions in the Northwest and California into the weekend, with wetting rain most likely west of the Cascades
- A surge in monsoon moisture today will temporarily moderate conditions for Arizona, Utah, and Colorado into tomorrow before rapid drying returns Sunday with very low RH and poor recovery
- Breezy for the southern Plains, strongest Saturday, while dry conditions persist for the Northeast with low RH in northern New England

Long-term (Monday through next Saturday)

- Well above normal temperatures are expected across much of the West mid to late next week, especially for the northern two-thirds of the Intermountain West with very low RH and poor overnight recovery creating long burn periods
- · The monsoon wanes early next week, with how far west and north the moisture moves late next week uncertain
- Another surge is most likely for Arizona with relief, but more limited moisture for the Great Basin and central Rockies may result in isolated mixed wet/dry lightning and several new ignitions if not large fires
- Lighter winds for the southern Plains, with a chance of thunderstorms at times next week, but widespread wetting rain
 is not expected, while the Northeast remains dry overall, with stronger winds possible late next week
- Impacts from Tropical Storm Erin remain uncertain and depend on where recurvature occurs, but increased swells are surf are likely at a minimum



Fuels Summary (Steve Larrabee)

Improving conditions Westside of north Cascades and along the Canadian border due to the atmospheric river. Improvement in coastal CA with cooler temperatures and the marine layer.

NR anomaly considering class thresholds, spotty rain coverage, vegetation stress and mortality.

Wetter soils but dryer fuels than anticipated in NR.
