## Weather Summary (Shelby Law)

## **WEATHER SUMMARY**

#### Short-term (through Sunday)

- Isolated to scattered showers are possible again today over the Northern Rockies, Utah and into Colorado with cooler temperature and elevated RHs
- A drying trend along the western states will slowly push eastward into Sunday, with isolated wet thunderstorms
  confined to areas east of the Divide by Saturday
- Rapidly warming temperatures are moving into the Inland Northwest and northern Idaho through the weekend with highs in the upper 90s.
- Relief for Oklahoma into the Lower Mississippi Valley due to abundant rainfall, but Texas will see more limited relief, while an increase in thunderstorms is expected across Florida
- · Scattered showers and thunderstorms for the Northeast today, but the Mid-Atlantic will remain dry

#### Long-term (Monday through next Saturday)

- A moderate strength upper-level ridge will build across the West for above normal temperatures and lower RHs.
   Temperatures up to 20°F above normal for northern California and the Northwest
- The monsoon continues in southeast Arizona and New Mexico, possibly spreading into southern/central Arizona and near/east of the Divide in Colorado for midweek.
- A chance of mixed wet/dry thunderstorms for the southern Great Basin and southern California beginning on Tuesday, possibly moving into northern California.
- Dry conditions are expected for most of the West with low RH and areas of poor overnight recovery, but significant fire
  potential will remain low for most areas due to this week's rain, with the highest potential in northern California and
  the Northwest
- The northeast US will be generally dry for the first half of next week before a strong trough of low pressure moves
  through bringing scattered showers to the area.



### **Fuels Summary (Mark Williams)**

Willamette FDRA will stay in the 97th to near record high ERC percentages for the next 7 days.

The far northwest of the NW are currently seeing record high ERCs that should decrease but will then stay above the 90<sup>th</sup> percentile.

N Idaho panhandle will see a slight decrease in ERCs.

Central ID will see a large ERC drop.
