Predictive Services Update

Weather Summary (Jim Wallmann)

WEATHER SUMMARY

Short-term (through Friday)

- Hot, dry, and unstable conditions to persist in Washington to the northern Rockies with significant fire growth likely, isolated dry thunderstorms, and potential pyroCbs
- Isolated to scattered mixed wet/dry thunderstorms for Oregon into the mountains of California today and tomorrow, with more wet thunderstorms likely Friday as temperatures cool
- Monsoon continues for the Southwest, West Slope, and Southwest with daily wet thunderstorms, with additional moisture from decaying Hurricane Lorena in the Southwest bringing very heavy rain and areas of flash flooding
- A cold front to bring breezy/dry northwest winds to the northern Plains tomorrow and freezing temperatures to the Upper Midwest, but areas of relief to New England and the Mid-Atlantic late this week

Long-term (Saturday through next Friday)

- Gradually cooling temperatures in the West, with a season-slowing event becoming more likely for the Northwest, northern California, and northern Rockies mid to late next week
- The monsoon wanes this weekend with breezy and dry conditions expected for the Great Basin, Southwest, and West Slope next week
- Cool and dry conditions for the Midwest to the Northeast next week with temperatures slowly warming through the week
- A tropical depression is likely to form in the western tropical Atlantic this weekend, some impacts possible for Puerto Rico and the US Virgin Islands, but it is too early to determine any impacts to the mainland US



Fuels Summary (Mark Williams)

Active fire areas in the NW are showing ERCs in the 97th percentile.

NW Mountains PSAs suggest ERCs improving to below the 80th percentile.

Temperatures expected to decrease along the western coast from Kettle Falls south to Happy Camp.

Risk Analysis (Rick Stratton)

NW and NOPS continue to increase fire activity.

SOPS fire activity will see slight uptick due to light fuels incidents.

WUI shows NW as the GA with the highest activity.

NW shows drastic increase in overall fire perimeter activity.

Implementing processes to address data analysis concerns.
