#### Who we are

The National Interagency Fire Center (NIFC), located in Boise, Idaho is the nation's support center for wildland firefighting. It is a place, rather than an organization. Nine different agencies and organizations are part of NIFC. Decisions are made using the interagency cooperation concept because NIFC has no single director or manager. NIFC has an interagency external affairs staff who work on agency-specific fire and aviation needs, as well as interagency projects and products to share the wildland fire management story.

#### What we do

- NIFC external affairs staff work cooperatively and often interchangeably to manage an interagency website and social media; communicate fire and aviation activities; address legislation and policy issues; provide statistical data coordinated with National Interagency Coordination Center (NICC) intel; and respond to requests from the public, news media, and elected officials.
- NIFC external affairs is dedicated to sharing the interagency wildland fire management story with the goal of enhancing national and strategic communications and policy planning; especially as real-time information sources continue to expand.
- Last year, NIFC external affairs completed a significant redesign of NIFC.gov and it remains a bookmark-worthy hub for fire information with a new, easy-to-navigate and streamlined design.
- Annually, NIFC external affairs provides national interagency fire year themes for public information officers to help communicate information to the public, media, partners, and elected officials.

#### NIFC external affairs and NMAC

- An external affairs representative attends the <u>National Interagency Coordination Center</u> (NICC) briefings and is included in <u>National Multi-Agency Coordination Group</u> (NMAC) discussions.
- External affairs staff write talking points and speeches, create presentations, and maintain an interagency social media presence. The staff also keeps NMAC apprised of national and local public and news media inquiries.
- External affairs staff coordinate all congressional, secretary-level, and other VIP visits to the fire center. They also coordinate VIP and media visits with incident PIOs.

### How we can help

If PIOs receive questions related to any of the below topics, please contact NIFC external affairs staff who can provide the information or arrange an interview with an NMAC member or subject matter expert.

- Large airtanker and Global Supertanker contracts handled by the USDA Forest Service (USFS).
- Single engine air tanker contracts administered by the BLM.
- Unmanned Aircraft Systems (UAS) program talking points and social media material. It is important to contact NIFC external affairs on this topic because of Secretarial Order 3379.

NIFC external affairs provides national, "big picture" information about the current fire situation; specific incident inquiries will be sent to assigned PIOs and PAOs at the local unit or the InciWeb incident contact identified.

Specific Geographic Area Coordination Center (GACC) inquiries, such as requests for information about firefighting personnel assigned to incidents within certain geographical areas, will be sent to the GACC.

### 2023 fire year themes

### COVID-19 and wildland fire suppression operations

- Wildland fire agencies have remained resilient throughout the pandemic and have adjusted guidance and protocols accordingly to keep firefighters, support personnel, and the public safe.
- All wildland fire agencies remain committed to safe, effective wildfire response during the COVID-19
  pandemic. Continued coordination with the Centers for Disease Control and Prevention on COVID-19
  safety guidance helps reduce exposure to the virus and decreases spread potential to firefighters and
  local communities.
- NMAC will continue to coordinate at all levels to help ensure another healthy and safe fire year.

### Information technology

- The Interagency Resource Ordering Capability (IROC), or resource ordering system, team continues to improve the program and its issues.
- The Interagency Fire Occurrence Reporting Modules (InFORM), or the wildland fire reporting system, team continues to work on the program and national fire reporting data processes.
- The <u>Wildland Fire Open Data site</u> for fire perimeter maps open to the public replaced GeoMAC in May 2020. All Open Data site requests and questions should be referred to NIFC's Open Data site support request form.
- The <u>Fire Enterprise Geospatial Portal</u> (EGP) provides standardized geospatial information for the full range of wildfire activities, from response to planning, and leverages a central source of spatial data for mapping, decision support, business intelligence, and situational awareness.

### **Complex Incident Management (CIM) transition**

- The NWCG Executive Board supports the systemic change from type 1 and 2 Incident Management Command and General Staff (C&G) to Complex Incident Management (CIM) C&G.
- The <u>NWCG Standards for Wildland Fire Position Qualifications</u>, <u>PMS 310-1</u>, was published January 20, 2023, to include the position qualification requirements for the seven C&G positions.

#### PIO subcommittee

- The Public Information Officer Subcommittee (PIOSC) was created in 2018 under the Communication, Education, and Prevention Committee (CEPC) under NWCG. The PIOSC provides national leadership in all areas of wildland fire public information management. It is comprised of representatives from all NWCG federal agencies and state representatives. - Social media guidelines for the entire fire community are available on the <u>NWCG Public</u>
   <u>Information Officer Social Media Reference and Guidance page</u> and it is also linked on the NIFC PIO bulletin board.
- The PIOSC is working closely with the Incident Positions and Standards Committee during
  the transition to the Complex Incident Management Teams. The PIOSC will provide updates
  specifically for the PIO positions during the transition. Updates are regularly provided on the PIO
  Incident Management Response Roundtable calls and any documents produced by PIOSC will be
  shared on the PIOSC website.
- The PIOSC created a graphic to explain the new PIO positions to aid PIOs in deciding when and how to proceed with training and development: What type of PIO are you? (nwcg.gov). This graphic will be updated soon for PIOC inclusion.
- The PIO technician, PIO3, and PIOC positions are approved and available to order in IQCS.
   PIO2 and PIO1 positions will remain in IQCS until phased out, this process is dictated by other committees and the NWCG Executive Board and not controlled by the PIOSC.
- PIOSC is working on updating the S-203 course for the PIO3 level and a new on-line self-study course for the PIOT.



### **Unmanned aircraft systems**

Verify whether your agency prefers "Unmanned Aircraft System" or another term through agency public affairs staff.

- In fire year 2022, there were a total of 15 SAFECOM reports of wildland fire drone incursions, which was less than what was recorded in 2021 (23).
- All DOI UAS operations are still regulated by Secretarial Order 3379, issued in January 2020 and
  Executive Order 13981 issued in January 2021. In preparation of relief from these orders, bureau UAS
  programs are drafting plans for transition to new fleet, training and policy expectations congruent to
  bureau priorities, and <u>Dingell Act</u> legislation mandating the deployment and integration of optionally
  piloted technologies.
- Agency-specific talking points will be available on the PIO bulletin board. Each agency at NIFC continues to educate the public about wildland fire UAS incursions and the issues associated with them.
- It is important to talk with aviation personnel when PIOs arrive at an incident to determine what is allowed by the host agency's aviation policy and attempt to develop a plan for media UAS flight requests.
- When there is a Temporary Flight Restriction (TFR) in place, the Federal Aviation Administration (FAA) is the authorizing agency, so work with your aviation personnel to refer the media to the FAA. If the FAA approves the media to fly within the TFR, you and the media will work with aviation personnel to determine the best flight time, location, flight duration and other safety-oriented logistics.
- As a PIO, please direct the media to work with incident aviation personnel to determine if, when, and where they can safely fly their UAS. If the media is not willing to coordinate with fire officials, they should be instructed not to fly. Document your conversation and notify the unit aviation manager, air operations branch director and/or other fire officials. They will work on the issue from there.

### Administration priorities

  - » Climate: The Biden Administration is ensuring we meet the demands of science, while empowering American workers and businesses to lead a clean energy revolution.



### Administration action to address the growing wildfire threat

In response to the growing wildfire threat, the Biden-Harris Administration initiated steps in 2021 to prevent, prepare for, respond to and protect the communities from extreme weather events and wildfires.

- Establishing the Bipartisan Infrastructure Law
  - » The Bipartisan Infrastructure Law provides more increased funding towards federal wildland fire programs.
  - » Fire staff on the frontlines deserve the right tools and training to keep themselves safe while protecting our communities and public lands from the increasing threat of fire.
  - » This funding goes towards improving firefighter pay, reducing hazardous fuels on the landscape, detecting wildfires earlier, supporting local communities in addressing wildfire risk, and restoring lands after a fire.
- Building a more responsible and resilient wildland firefighting resources by:
  - » Bolstering firefighter pay.
  - » Extending hiring of temporary firefighters to ensure effective response throughout the fire year.
  - » Transforming the workforce to a more permanent federal firefighting resource to enable a more consistent response to the growing wildfire season.
- Improving wildfire responsible capabilities by:
  - » Providing a robust response through federal firefighters and additional surge capacity.
  - » Continuing to train and equip military personnel to be ready to quickly support wildland fires as
  - » Increasing aviation capacity to support immediate response and provide critical financial support to assist in wildfire response.
- Using data and technology to protect communities by:
  - » Including leverage satellite and emerging technologies to rapidly detect new, often remote, wildfires.
  - » Using research to improve early detection wildfire sensors.
  - » Using the latest science and technologies to enhance wildfire response.
  - » Preparing to address potential power impacts as a result of wildfires.
  - » Using research and modeling to protect firefighter and residents from smoke and dangerous air; Providing actionable information to help Americans stay safe during a wildfire.
- Reducing risk of wildfires through hazardous fuels management and mitigation investments by:
  - » Providing assistance to mitigate the impact of future wildfires and protecting communities.
  - » Investing in infrastructure to build resilience to wildfires and helping western communities prepare for drought and extreme wildfires.
  - » Implementing more effective treatment of hazardous fuels.



#### InciWeb

- InciWeb is a public, information sharing website for current wildfires, fire-related activities, and all-hazard incidents. It is considered an interagency tool, although the USFS is the lead agency responsible for managing the site, IT maintenance, etc.
- The open-source web content management system behind InciWeb has changed to Drupal. The public-facing aspect is mostly the same, but the update significantly changed the back end of the system to make it more user-friendly. There are trainings on the PIO bulletin board here.
- InciWeb is for active, current incidents. It is NOT for archival or historical purposes. Incidents older
  than one year must be cleared from the system to help ensure there is server space for use on current
  active incidents. This includes manually clearing out photos, maps and video after an incident is
  closed out.
- Federal, Tribal, state and county officials can use InciWeb to create and update incidents on their

### Photographers contracted by NIFC partners

- PIOs cannot name request photographers.
- The USFS has several contractors on blanket purchase agreement (BPA) and can mobilize them based on availability and proximity to requesting incident.
- Some of the contractors can do both videography and photography. Please identify what services are needed.
- Contract specialists likely do not work weekends or after hours. It is important to anticipate a need for a photographer ahead of a holiday or weekend.

- The BLM also has a BPA, but it takes one to two weeks to get the process approved. If PIOs would like more information about it, please contact Jennifer Myslivy at <a href="mailto:jmyslivy@blm.gov">jmyslivy@blm.gov</a>.
- USFS contracted photographers can only be used on USFS fires. The same goes for BLM fires and BLM contract photographers.

#### **FireNet**

- Since 2018, FireNet is recognized by NMAC as the official electronic messaging and file system in support of the interagency wildland fire mission, which complies with legal and policy mandates regarding security and privacy. The FireNet transition to Microsoft Teams occurred in 2020.
- The PIO Toolbox is a public group located on FireNet SharePoint. It was developed for PIOs to share resources and network with wildland fire PIOs nationwide.
