### AGENDA ITEMS:

#### 1. Election of the new committee co-chair (Ellsworth)

#### 3. BLM Wildland Fire Training Standards (Ellsworth)

Mike asked the group if they had issues with the issue paper to the FOG regarding the requirement of leadership courses for certain fireline positions and the need for a transition plan should the recommendations be adopted. BFTC members would like more time to discuss the issue with fire managers.

**5. Engine Captain Issue Paper (Ellsworth)**

Mike discussed revisions made to the Engine Captain issue discussed at the fall meeting as well as the need for a transition plan should the recommendation be adopted. Mike will formalize the issue paper which will be presented to the Engine Committee by Jeff and Mike later this month and then to the FOG in November. BFTC members discussed changing Red Book language and wanted more time to talk with their people.
